## A. CALL TO ORDER - Invocation, Pledge of Allegiance, Roll Call

Gahanna City Council met in Regular Session on Monday, May 1, 2000, in Council Chambers of City Hall, 200 South Hamilton Road, Gahanna, Ohio. President of Council Debra A. Payne called the meeting to order at 7:32 p.m. Council Member Mike O'Brien delivered an Invocation, followed by the Pledge of Allegiance, led by O'Brien's Student Counterpart, Kristin Hanna.

President Payne noted this was Student Government night and had all persons on the dais introduce their student counterparts. In attendance were Scott McLaughlin, Student Mayor, Christy Ayotte, Student Council President, Student Council Members Chris McComb, Talia Calig, Julie Zeldin, Emily Alexander, Kristin Hanna, and Student Clerk of Council Reena Patel.

## B. ADDITIONS OR CORRECTIONS TO THE AGENDA.

Motion by Angelou, seconded by Kneeland, to add a motion resolution to the consent agenda at the request of the Interim Director of Public Service for rebid of the Integrated Mailing System Machine.

## C. HEARING OF VISITORS

Marlene Eader, Gahanna Jefferson Board of Education, stated this was her first opportunity of participating in Student Government Day; also want to let you know how much I enjoyed Arbor Day activities; also like to thank Chief Murphy for his help in maintaining a safe school environment and prevent disruption at the end of April; passed at last meeting a plan to have middle school football team; proposals for redistricting are being finalized; will be a public meeting on the 12th at Middle School West at 7:30 p.m.; an outline of the proposal will be sent to all parents at the beginning of next week; had an opportunity to have special visitors two weeks ago in recognition of Tom Gregory; wonderful recognition from Time Warner; Teacher of the Year cash prize for him and a cash gift to the class; in attendance were President of Time Warner and Executive Vice President; appreciate your recognition of him this evening and Jean Arthur of Time Warner is also here.

Ron Piehler displayed a wooden Wally; noted that the Creekside Festival will be held June 17; will be having Wallys on Parade; challenge Council to each get a Wally and decorate it. Payne asked where our Wallys would be displayed noting that businesses will display them in front of their business. It was suggested that Council's could be at one of the Council rings or in other public spaces. Piehler noted that the idea had been mentioned at the Olde Gahanna Community Partnership meeting by Hogan; saw it in Chicago with cows and New York is doing this year; that's where idea came from; he pledged to do one for Insurance Advisors; will have 2 coats of white paint on them; use your imagination to dress them; James Arnold is doing a golf theme. Payne stated she would do one. Hogan noted they are portable and can be carried in and out of businesses. O'Brien noted he appreciated Piehler's involvement with Gahanna.

Philip A. Reynolds, Lot 1178, Hideaway Hills, Ohio stated he was a sales representative for International Mailing Systems; concerned that you are going to rebid the mailing system; we, along with Pitney Bowes, were the only ones that submitted bids and we

were the only one that submitted a correct bid on time; Pitney Bowes was not sealed and was 10 minutes late; were numerous problems with it; our bid was \$25,000 less than them for a comparable machine; on February 22 met with Terry Jordan and made agreement to bring our machine in and do a trial run; machine is in building and test run went fairly flawlessly; to the best of my knowledge everyone was satisfied; in the meeting we had with former Service Director it was agreed it would stay in place if it worked; requesting that you honor that agreement, not rebid, and move forward with an award of the contract. McGregor stated it was his understanding that employees are not satisfied; part of the lower cost was that present unit does not have a postage applicator or whatever it is called. Interim Director of Public Service Hall stated the machine has been tested and it jams frequently; can't use our people and time in that fashion; other machine has drawers, rollers, etc. also this machine doesn't fold; thought it would be better if we write specific specs that meet our needs. City Attorney Weber stated he recommended this step; one bid was incomplete; second bid was complete but product was not deemed acceptable; the Service Director always has option to reject bids; in this case there was also the issue of whether specs needed refined; based on those facts I suggested that it be rebid. Payne noted that from the Council perspective saw a great variance in price and encouraged Service Director to bring equipment in; always want to go with lower bid but it does need to meet our needs; understand that was not necessarily the case after the test. Reynolds stated their machine can be put in line with postage meter for \$5,000 more; secondly equipment is superior as far as print quality; we are at 1600 dpi vs 600; our machine is also able to put e-stamp on which Pitney Bowes can't do; our cost per copy is about half to two thirds of theirs; cost for supplies and maintenance will be much greater; ours is less; our entire process is with one printer vs two in their machine; our footprint is smaller; their machine has not been in here to the best of my knowledge; only showed at their office; would challenge you to have it brought in; numerous customers have found that it has its faults also; to buy off a demo in sales room is not a fair comparison; any folding or inserting equipment is the most problematic piece of equipment you will ever have; every time you fold paper and put it into an envelope you will have jams; yes they do need to be cleared out; in this large Pitney Bowes there are many more places for paper to jam; run through a longer footprint causes more chances of paper to jam; ours is a small footprint to go through a small distance; by specing us out feel you are doing yourselves and the taxpayers an injustice; have Pitney Bowes bring their machine in before you send specs out; would hate for you to make a \$25,000 mistake. O'Brien noted that a comparison between two machines shows this machine only holds half of what the Pitney Bowes does. Hall stated there was no comparison; to say it worked flawlessly is not correct; had to pull out 50 envelopes; feel there will be a lot of time spent to keep this machine running; you can't just pull out a drawer; you have to pull it apart and there is not enough room to do all that; O'Brien noted that several municipalities use the Pitney Bowes; none were mentioned that use this machine. McGregor stated this is a new machine and in the rebid it would never be our intent to spec anybody out; would be this machine or an equivalent so people can bid; our intent would be to have it bid; can test Pitney Bowes before we make a recommendation; Angelou stated that Jordan told Council this was coming to us on a trial period; was your request because it was new; don't believe it was ever said to us it would remain here; this was to be a trial period; memo we got stated jams were numerous and difficult to unjam; was various issues for many departments; to say we would automatically give you bid and machine would remain is not really correct. Reynolds stated they did request to bring it in because we wanted you to see it in action; we are a local company; reason requested we bring it in was that if it worked it would stay; with a new piece of equipment you will have jams as it sets up; highly recommend that you put in your bid specs that the machine come in on a trial basis; as an ex Pitney Bowes employee know they will do that; Angelou stated it seems company felt if it was brought in on a trial it would expect that it remain; that is not the way

government operates; could never say that would happen. Reynolds stated that after bid and we were lowest and only bid that met the bid opening we agreed to a test and stated that if it did its job it would remain; Jordan agreed to that; machine did get the job out. Payne stated that's where the difference of opinion is; you are saying that if it does the job at all and we are talking quality of the job; we were talking a lot of money for this; need to accomplish in a satisfactory manner; Service Director has rejected the bids; is only appropriate for us to rebid.

Eader thanked Angelou for sharing with the students. Angelou stated she volunteers and thinks students at the high school should be commended because they cheer students on; they can feel a part of the school; they are a part of the Lincoln High School community; wonderful tribute to see them up there and thank Gregory.

Jean Arthur, Manager of Community Relations, Time Warner, stated it was a nice recognition ceremony at the school last week; he is very modest and has been recognized through the Columbus Educator Awards Program; was a national winner last year against plenty of competition; we provide free cable service to all libraries in schools; also have about 500 hours of commercial free educational programming for schools to use and tape; also have free curriculum guides on line; involved in ESPN class this year and was a local winner; usually give \$500 cash and he has asked that we give him a grant for equipment instead; a TV and VCR going to the handicapped classroom.

Weber stated he had met with Coleman and various other city officials regarding the status of SB289; very good meeting and useful; Mayor Coleman came out forcibly on this that it is not workable and need to kill it; asked coalition to change its position from compromise of the bill and going into total opposition; may change its stance and go into opposition; said that under the bill as currently written there would be no annexations without township approval; trying to massage will not work; point I made was that we need to involve persons from outside of Central Ohio; involve some of the mayors of larger cities and try to have more of a statewide concerted effort against the bill; very fine editorial in the Dispatch against this bill.

## M. COUNCIL COMMENT

James Arnold thanked counterpart for being here; last Tuesday night was the presentations at school to honor Russ Cochrane; presented him with Mayor's proclamation and Council's resolution; with all the problems happening in schools, we are winning national awards and where are the news media? O'Brien stated he won't make luncheon on Wednesday; as to the trip to San Antonio, can't express the pride I have in this community; were able to give a presentation at a workshop put on by Urban Spaces; was a national workshop with Los Angeles, San Bernadino, Dallas, Carlsbad NM and some smaller communities like Camden Arkansas and Bristol TN who has huge resident support; proud of the presentation the Mayor and members of Council gave.
