A. CALL TO ORDER - Invocation, Pledge of Allegiance, Roll Call

Gahanna City Council met in Regular Session on Monday, August 6, 2001 in Council Chambers of City Hall, 200 S. Hamilton Road, Gahanna, Ohio. Vice President of Council Michael O'Brien called the meeting to order at 7:30 p.m. Council Member Debra Payne gave the invocation followed by the Pledge of Allegiance led by Scout Paul Emch, Troop 781, of Shepherd Church of the Nazarene.

B. ADDITIONS OR CORRECTIONS TO THE AGENDA:

MOTION was made by Payne, seconded by Kneeland, to add ORD-0172-2001, ORD-0173-2001, ORD-0174-2001, ORD-0175-2001, ORD-0176-2001, and ORD-0177-2001. ROLL CALL: Voting yes: Payne, Kneeland, Shepherd, Hogan, O'Brien. Motion carried.

HEARING OF VISITORS:

David Goodman, State Representative, stated he didn't have an agenda; here to say hello; am available to you; have been working hard to pass our biennial budget; with 45 new legislators and time we were able to do it; was a difficult process; had an \$800 million shortfall; we did add \$1.3 billion to education; did it all without raising your taxes; Gahanna has been concerned with annexation reform; there is a potential for a referendum; encourage you to work hard on that; did try to modify as best we could but was a lot of push in the opposite direction; bill itself could have been worse; feel it is the best possible compromise that we could come up with; that's all I have; I'm still out there; now know that Gahanna has parades rain or shine; were a lot of folks out there watching us; am glad to answer any questions any time you need me; always willing to help Gahanna; call me at any time.

O'Brien stated that most of us appreciate your position on annexation reform; you represent our community well; sincerely appreciate your stand and the stand you continue to take. Goodman stated there are a lot of different interests in the state; learned a lot in this process; is a different kind of growth down in the Cincinnati area; tried to explain to them how we work through our forms of government; growing townships is a type of acronym; don't think our constitution anticipated that; think we accomplished a lot; made it more difficult to annex but not in such a way that we won't have growth any more; feel you will continue to grow as long as we cross our t's and dot our i's; encourage you to follow through.

Joe Kolar, 1215 Rice Avenue, thanked Council for the opportunity to address them; we need your help; the pond on Rice Avenue is deteriorating beyond what we can take care of; need your resources to bring it back to standard; there is a lot of erosion which has made the banks very steep; don't think a child could get out of the pond if they fell in; algae is overgrown and it almost looked like you could walk across it, it was so thick; mosquito problem is terrible around the pond; when we look at the entry way and the job done at Creekside, all we ask you is for guidance and to help us make this pond something to be as proud of; the area needs chemical treatment or aeration; life is choking out of this pond; a sidewalk was put in 5 years ago which sits about 4" higher than the soil around it; could easily trip off of it and sprain your ankle; there are also

some hazards around the pond that need addressed; O'Brien was out and looked at the area today; fishing is almost impossible now; many people did fish the pond and enjoyed it; is now beyond enjoyment; people in the community have been helping out; we have tried to cut grass and worked on weeds; have gone house to house and have signatures from over 40 homes to say that this pond area needs repair.

O'Brien stated the petition will be a part of the record; this pond does not be to aerated or something done that could help us to stop erosion and bring safety to the children; is a hazard to walk. Kolar stated that we do need to continue our volunteer work but need your resources to make this happen; people have come out tonight to show you that the neighborhood is serious in wanting to clean up this area. (Clerk's Note: Approximately 15 people stood) Kolar continued that the mosquito population continues to grow; the area does have a bad smell in the evening; people don't play with their children or walk pets their any more; would like to see it become an asset again.

Payne asked if this was city owned or privately owned like Rose Run. Mitchell stated this is a city owned retention basin. McGregor stated this was different than Rose Run; we maintain this like we do others; some parks like Royal Plaza have extensive volunteer network of people who work on that park; they call and tell us they need top soil and we will bring it out; last summer they had concerns with our big mowers going in; this year we provided them with a grant to hire a student in the area to mow the area; we are very available to work with neighborhood civic associations to make it what you want it to be; some are not interested in storm water detention facilities and we just mow the areas; Rose Run is supported. Kolar stated there is a lot of potential; a little rock to stop erosion may be all that is needed to address that issue; we just don't have that type of expertise; need some resources.

Hogan suggested the City may want to take a look the development on Clark State just past Uxbridge; there are 2 detention basins where they have put these aerators that shoot water in the air; keeps all algae out of there; could assign this to Service Committee to allow for further discussion. McGregor stated he believed those basins were owned by the Civic Association and not the township.

O'Brien asked if McGregor and Mitchell could meet with Kolar; did spend some time out there; my observations concur with what was said; erosion on the east side about the center near the figure 8 is extremely bad; banks are steep where they have eroded; shallows are filling in as it erodes; lots of algae, probably 2 to 3 feet out into the pond; there is a dead animal in a stage of serious decay on the far south end; catch basin was filling up with debris; the weeds are probably helping to keep the soil back but is making it impossible to fish; understand we now have a naturalist on staff; maybe this could be looked at from that standpoint. Mitchell stated that could be done; the pond was built with steep banks; have tried in the past to seed some tall fescue to try to stabilize the banks; could probably do some stoning; am most concerned about and should have been aware of the sidewalk issue; will jump on that quickly. O'Brien stated it was very noticeable; rip rap was a question I had; also wanted to point out the catch basin issue; if we could aerate possibly a neighbor could provide power; not sure what it would take to add oxygen; was surprised by the nature; the songbirds are thriving; one bank was almost all Canadian thistle; bass and blue gill both are living in the pond; songbirds thriving to the east; thought I would see a ditch to hold run off; this is a pond that could be thriving; hopefully we can help; sounds like the administration will address; however, will go along with Hogan's suggestion; this issue will be placed in Service Committee as a monitor item to keep abreast of what is going on.

Sadicka White, Director of Development, stated there are several amendments being proposed; procedurally has been through Planning Commission with a recommendation for approval; wish to add a new Restricted Institutional District; in the history of our City, schools and churches are zoned residential; we started from town centers and walked or took public transportation; some institutions have taken other items on; some are what I call mega churches and they are huge in terms of impact to a neighborhood; they also provide many ancillary kinds of services; the parking demands for these kinds of institutions are phenomenal; some are as large as shopping centers; some operate on a day to day basis with that kind of traffic; have much more impact on our neighborhoods; where churches usually located in residential areas they were permitted and conditional uses; looking at this new classification and for that to change; there are different standards that are necessary in terms of setbacks, extent of lot coverage, and development standards; particularly under the final development plan so we can look at in total; has taken us quite a long time to do this; Gard and Sherwood and other staff members worked hard on this in an attempt to make as easy a transition as possible; will benefit the residents and parishioners.

President asked for opponents. There were none.

President closed Public Hearing at 8:01 p.m.

In response to question, Sherwood stated that if you read the legislation on the Restricted Institutional District and get your questions answer on that, the necessity for the other changes will fall into place. McGregor stated that the volunteers who took things out were not exposes; items taken were windows, doors, etc.; things that are self contained; asbestos is mostly in the heating system; if you take out duct work and the like you might have exposure; copper plumbing was salvaged; there is no asbestos associated with that; not aware of any problems with the salvage operation.

Hogan stated he did have real problems with this ordinance; City paid \$475,000 for this property; we are nowhere near the stage where this building had to come down; should have been rented or leased so the City could have gotten some money back; any good developer would have done that; other concern is that this building was gutted without the approval of Council and no authorization; Mayor did state at a meeting that Council passed a plan and Council gave him directive to fast track Creekside; we didn't vote on anything to fast track Creekside; bottom line is that this points out why we need these public meetings to hear what the public has to say; we don't know if Phase 2 can be completed; we don't have Stilson report yet; we don't need more parking; we may need to demolish this building at some point but think we could have rented this building for 9 months 1 year, 2 years or 3 years and gotten a return on our investment.

McGregor stated he have placed effective parking on the south end of downtown and at Memorial Park; there is pretty good parking in central downtown area; the old village wasn't developed with parking in mind; some businesses have 0 parking; at north end we were able to work out combination agreement with EMH&T and the small church but we have no public parking up there; this will be the only public parking available; in terms of fast tracking, Council decided on recommendation of the administration to do the low water crossing this year; it was a 2002 project; getting across to the west side was important we put this on the front burner; and Council voted on that and on adopting the plan; apologize if I misunderstood the intent; fell it is a very good investment to build that parking now; feel it will be put to good use.

O'Brien stated the only thing he heard on fast tracking was the low water crossing. McGregor agreed that was what was talked about; to get as much done as possible this year on that; on a side note on the Summerfield property, Development has received 22 requests expressing interest in an RFP for that site. O'Brien stated that was the only thing on to be fast tracked; no desire to fast track anything else; that's why we need the Stilson report; that changes a lot of things; may be a new and different concept; was our collective wisdom to wait; many things requested in our E-mails like the one from Gen. Abraham that brought up some great questions; can't answer them until next phase of report is back; moving slowly with this so we make good decisions based on what many

public hearings have brought out; we need to know the direction people want us to go but we can't go any further until we get more engineering studies back; is still plenty of time for Public Hearings at both the Council and Planning Commission levels; won't see any bulldozers building a skating rink; was never the intention to build a skating rink; we talked about a canal that will aid in the continued development of Creekside; suggestion was brought up to use the canal more than just the summer; that idea came from the residents by way of providing some means of draining and freezing; where it got out we were in competition with Chiller, I don't know; that was not the intention of Council; probably have said too much; those are things that are of concern; nothing was fast tracked; to those who think it has been we are proceeding very cautiously and judiciously.

A motion was made by Council Member Payne, seconded by Council Member Hogan, that this matter be Adopted. The motion carried by the following vote:

but 22 or 23 people writing letters make a big difference.

Shepherd reminded everyone that it is their responsibility to give accurate information to people; when they are given the information factually they understand what we are trying to do; we don't require extra public meetings; they do understand; we are talking about a water feature not an ice skating rink; it can be verified; it is the responsibility of everyone who sits here to give accurate information.

O'Brien stated he was glad to see residents here on the pond issue; hope we can get it back to where it should be.
