#### 1. 2015 Street Program - Award Contract

Rob Priestas, City Engineer, said request was to award contract for 2015 street program; opened bids April 3, 2015; bids reviewed and based on our reviews, Strawser was lowest, best, most responsive and responsible bidder; came in below engineer's estimate; \$2.64 million; funding from multiple sources; request waiver and emergency. Kneeland asked when project will start. Priestas said hoping as soon as school is out; will work closely with contractor once awarded; hopefully we'll finish before school starts.

#### 2. Morse Road Improvement - Columbus Cooperative Agreement

Priestas requested a modification to cooperative agreement; entered into contract in 2014 with City of Columbus for widening of Morse Road from US 62 to Trellis; we have asked for additional improvements to make it a complete project; requesting emergency and waiver of second reading since project is currently under construction.
