# C. HEARING OF VISITORS

#### Windy McKenna, School Board

McKenna reported on the March meeting where they recognized Eastland inductees Tom Kneeland and Chief of Police Dennis Murphy; advised their Bond rating went very well; they awarded the Administration contracts, which they do every year. Dan Griscom was hired as the school district's treasurer and will start May 10. Reminded that the April meeting will be the third Thursday, April15. President noted that Tom Kneeland would be the Council representative at this meeting.

#### John R. O'Meara, Metro Parks Board

O'Meara addressed the 0.65 levy, which is to be on the forthcoming ballot, which he said is slightly over present levy that is expiring; said on \$100,000 home evaluation, this would be less than \$20 per year; said they currently have 11 open parks; are working on one southeast of Columbus of 500 acres; future work will be with the City of Dublin, Darby Creek, and Pickerington Ponds. Advised that a significant part of the levy is for the green ways program. Said they would like to work with Gahanna and other communities.
