

Executive Summary

Thank you for this opportunity. We are pleased to provide you with a quote regarding the above referenced project. Please see the following price and scope of work and let me know if you have any questions.

Scope of Work - Conduit Fiber Install:

- Place fiber in the newly placed TIZ Phase 1 conduit project (built by others).
- At the manhole along Tech Center Drive, splice (144) strands of a Single-mode fiber optic cable to an existing fiber optic cable that routes along Tech Center towards Morrison.
- Furnish 5,200 ft. of 144 Single-mode fiber cable.
- Update the Fiber Maintenance Contract to represent this new section to include:
 - o Registration with OUPS
 - Ongoing facility locating
 - o Fiber restoration services

Scope of Work - Aerial Fiber Installation - Taylor Rd: OSP Construction -

- Engineering / working with AEP for pole submittals and IJUS for make-ready assessments
- Build Strand and Fiber Approx. 2,040 ft. length
- Place Anchors and Guvs 3
- Build Risers 2
- At the manhole near the intersection of Morrison/Taylor Road, splice (24) strands of a new 144-strand Single-mode fiber optic cable to an existing fiber optic cable that routes up Hamilton to a manhole outside of City Hall.
- On Taylor Road, splice (24) strands of a new 144-strand Single-mode fiber cable to a hand-off tail that will tie into the existing Gahanna 144 Single-mode fiber cable.

- Based on the assumption that the conduit is proofed with either a jet line or pull string.
- All tasks in the Scope of Work is quoted during normal business hours.

Payment terms are NET 30 for labor upon installation.
