BASIS OF BEARINGS: Bearings are based on the Ohio State Plane Coordinate System, NAD83 South Zone (1980 Adj.). A bearing of $8^{\circ} 33' 55" 24"$ W was held between Franklin County Monuments ECRH 4524 and ECRH 4524 Road.

SOURCE OF DATA: The sources of recorded survey data are the records of the Franklin County Ohio Recorder maintained in the plan and tax of this office.

IRON PINS, where indicated, unless otherwise noted, are to be set and are iron placed, thirteen-sixteenths inch inside diameter, thirty inches long with a plastic cap glued in the top flange of the foundation. "ADVANCED T&E"

PERMANENT MARKERS: Permanent markers, where indicated herein, are to be one-inch diameter, thirty-inch long, solid iron rods, are to be set with the top end flush with the surface of the ground and then capped with an aluminum cap stamped "ADVANTEN".

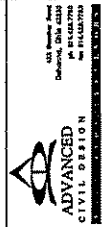
