## I. INTRODUCTION AND SUBMITTAL OF A PETITION TO RENEW

On August 17, 2020, pursuant to the provisions of Ohio Revised Code §4301.82, Gahanna City Council approved and enacted a Designated Outdoor Refreshment Area (DORA) to be known as the "Creekside Outdoor Refreshment Area" (CORA) in downtown Gahanna. As created, the City administration and the CDA had the authority to change the plan, within the terms set in the petition, as needed.

Section §4301.82 of the Ohio Revised Code authorizes municipalities to create a Designated Outdoor Refreshment Area. Five years after creation, State law requires that the establishing legislative authority shall review the operation of the area and, by ordinance or resolution, either approve the continued operation of the area or dissolve it. Prior to adopting the ordinance or resolution, the legislative authority shall give notice of its proposed action by publication in one newspaper of general circulation in the municipal corporation or township or as provided in section 7.16 of the Ohio Revised Code. The Division of Liquor Control is then responsible for issuing permits with the "Outdoor Refreshment Area" designation on it to all A-1, A-1-A, A-1c, A-2, A-2f, or D liquor permit holders, (except a D8 class that holds a C class permit) that are in the DORA.


In summary, this petition proposes the following:

- The continuation of a CORA to enable individuals to walk within the CORA boundaries with an alcoholic beverage purchased from a liquor permit holding establishment.
- The expansion of the CORA boundaries generally north to Carpenter Street and east to Short Street. (See Section II Boundaries for more detail.)
- The expansion of the hours that CORA will be in effect to 11 A.M. to 11 P.M. Monday through Sunday. CORA would be suspended during certain special events that historically take place within the boundaries of the proposed CORA. These special events could include the Creekside Blues & Jazz Festival and Creekside Hops & Vines Festival, as well as any additional event identified by City Council.

### II. PROPOSED EXPANSION OF CORA BOUNDARIES

The City of Gahanna is a municipal corporation with a population of 35,726 as reported in the 2020 federal decennial census, which allows the creation of up to three outdoor refreshment areas as outlined in O.R.C. §4301.82(D)(2).

In accordance with O.R.C. §4301.82(B)(1), the boundaries of the proposed expanded CORA are shown below. This expansion will allow future Creekside redevelopment, a boutique, the Sanctuary event center and parking lot, and the City-owned surface parking lot on the east side of N High Street to be included in the CORA:

#### **DESCRIPTION**

Commencing at the northwest corner of the intersection of Granville Street and Mill Street, traveling westerly to the eastern boundary of Big Walnut Creek, then continuing northerly along Big Walnut Creek to 169 Mill Street's northern property line, then continuing easterly along Carpenter Street's centerline to the intersection of Carpenter Street and Short Street, then continuing south along the centerline of Short Street to the intersection of Short Street and Ogden Alley; then continuing westerly along the centerline of Ogden Alley to the intersection of Ogden Alley and North High Street; then continuing southerly along the centerline of North High Street to the northwest corner of the intersection of Granville Street and North High Street, then continuing westerly along the centerline of Granville Street to the point of commencement. Said description contains 27.0 acres.

Pursuant to O.R.C. §4301.82(F)(1)(a), a street boundary listing is provided in Exhibit "A".

# III. NATURE AND TYPE OF ESTABLISHMENTS

# V. LAND USE & ZONING

In accordance with O.R.C. §4301.82(B)(4), the uses of the land within the CORA are zoned CMU, Creekside Mixed-Use, and is in accord with Gahanna's land use plan.



#### VI. PUBLIC SAFETY & HEALTH

In accordance with O.R.C. §§4301.82(B)(5), 4301.82(F)(1)(d), 4301.82(F)(1)(e) and 4301.82(F)(1)(f), the requirements for ensuring public safety and maintaining the appearance and public health of the area within the CORA are outlined below.

#### A. Safety Plan

The Safety Plan will help to ensure public safety within the CORA and will designate the number of personnel needed to execute the Safety Plan as follows:

- i. The Gahanna Division of Police ("GPD") has multiple resources to maintain public safety within the CORA to include the downtown core business district. GPD has flexibility when deploying resources and has strong experience in dealing with large crowds in the Creekside District.
- ii. Given the potential for high pedestrian traffic and increased vehicular traffic within the CORA during the times it is in effect, directed staffing shall be applied by the GPD to ensure public safety. This will consist of a minimum of one police officer who will patrol the CORA district as a part of his/her assigned patrol responsibility.
- iii. The on-duty GPD supervisor will ensure that appropriate measures are taken for adequate staffing and supervision of activities occurring during CORA operational hours, based upon attendance and nature of events.
- iv. The Chief of Police may assign additional officers to events occurring within the CORA or establish other staffing mandates based upon activities that are expected to occur. To help supplement the regularly scheduled GPD officer(s) on peak weekdays and/or weekends, extra dedicated officers may be assigned to the CORA either by the GPD or may be contracted for service through the City of Gahanna by liquor permit businesses within the CORA who shall pay to the City the special duty cost for providing the extra officer(s). The primary responsibility of the contracted officer(s) will be the CORA district. If extra dedicated officers are required to be assigned to the CORA due to a special event that is being presented by an organization, the organization also will be required to share equally in the special duty cost of the extra duty officer(s).
- v. The Chief of Police, other members of the City of Gahanna's staff, as directed by the Mayor, and CORA stakeholders, shall meet as needed to review the Safety Plan herein to determine whether updates, modifications, or supplementation may be advisable or required. In the event it is determined that the safety plan should be changed, such changes shall be executed administratively. The Chief of Police has determined that the Safety Plan described herein is sufficient to maintain public safety within the CORA. This Safety Plan can be executed with the existing personnel of the City of Gahanna.

#### **B.** Sanitation Plan

The City intends to use a combination of the existing relevant provisions of the Sidewalk Dining Code and Park Conduct Policy (Chapters 908 and 563 of the Gahanna Code, respectively) to maintain the appearance and health of the downtown Gahanna area and to ensure that the area is not adversely impacted by the CORA.

## i. Trash Receptacles:

Each qualified liquor permit holder will be required to provide and maintain trash receptacles at all entrance/exit points at their individual establishments at the discretion of the City of Gahanna. The permit holders shall each be responsible for collecting litter near or around each of their occupied premises.

Trash and recycling receptacles will be distributed and serviced throughout the CORA area by the City of Gahanna Parks & Recreation Department. The Department will regularly service trash and recycling receptacles on a weekly basis or more frequently, if needed, based upon activities and events occurring in the area.

Upon approval of the Director of Public Services for the City, additional trash or recycling receptacles may be added by the city or any qualified permit holder, and the servicing of such receptacles shall remain the responsibility of the installing entity.

# ii. Street Sweeping:

The Director of Public Services shall evaluate the need for, and frequency of, street sweeping and servicing of trash receptacles, and, if needed or advisable, implement changes or modifications to the Sanitation Plan from the commencement of the CORA until its dissolution.


The Directors of the Gahanna Parks & Recreation Department and the Department of Public Services have determined that the Sanitation Plan described herein is sufficient to help maintain the appearance and public health within the CORA. This Sanitation Plan can be executed with the existing personnel of the City of Gahanna.

#### VII. ADDITIONAL INFORMATION

The following sections provide additional information regarding the proposed operations and logistical arrangements for the proposed CORA in the downtown Gahanna area.

#### A. Proposed Signage

In accordance with the ORC §4301.82 F(1)(b), signage will be placed designating the boundaries of the CORA. The location and spacing of the signs are shown on attached Exhibit B. The signs will be mounted and located at street intersections, streets, and exit points along the boundary of the CORA. The content and style of this artwork shall, in sum or substance, consist of the following:



#### B. Rules of the Area

# i. Proposed Hours of Operation of the CORA

The Designated Outdoor Refreshment Area will be in operation from 11 a.m. to 11 p.m. Monday through Sunday. Extended times for special events may be established by the Mayor with the concurrence by a vote of City Council. Such concurrence would be made by motion.

The CORA shall remain in effect during these identified hours of operation unless otherwise temporarily suspended on pre-identified days or during pre-identified events. Such events may include the Creekside Blues & Jazz Festival, Creekside Hops & Vines Festival, and any other events identified by the City.

#### ii. Official CORA Cup

Pursuant to O.R.C. §4301.82(F)(1)(g), all beer, wine, or intoxicating liquor must be served solely in a plastic or non-glass container within the CORA. In compliance with this provision, all CORA beverages must be served in a new, unused Official CORA Cup. No other container will be permitted.

Used official cups from one liquor permit holder establishment shall not be carried into the establishment of another liquor permit holder and must be disposed of before entering that establishment. Other businesses within the CORA that are not a liquor permit holder will have the option to determine whether to permit a CORA beverage within their establishment. In that event, the business shall post a sign at its entrance, specifying that CORA beverages are permitted to be carried inside.

The participating qualified liquor permit holders will include a "to go" charge on every CORA beverage sold, with the Official CORA Cup. The "to go" charges will be used to fund the costs associated with the enforcement and implementation of the CORA, including costs of certain supplies, and any additional costs incurred as a result of the Safety and/or Sanitation Plans outlined herein.

The Official CORA Cup will be able to hold no more than sixteen (16) fluid ounces and will be composed of plastic or non-glass material. (A copy of the proposed Official CORA Cup for the Creekside District is below.)



## C. Public Enjoyment of CORA

A member of the public who elects to participate in the CORA can expect to enjoy the CORA without legal restrictions as long as that CORA participant correctly follows all of the Rules of the CORA area and maintains a decorum of good behavior, free of public drunkenness, property destruction, or any action that disrupts the enjoyment of another CORA participant, or disrupts any establishment, property owner, resident, or patron within the CORA.

Violation of any of these Rules of the CORA shall be considered a minor misdemeanor and violators face warnings and/or fines up to \$150.00 in accordance with O.R.C. §4301.62.


### **D.** Positive Economic Impacts

The CORA is supported by the business establishments and residents within the defined district. The CORA distinguishes the Creekside District and enhances the experiences of patrons of business establishments and the attendees of events in the downtown Creekside District. It increases the economic impact, value, and visibility for restaurants and merchants. CORA is an economic development tool to draw shoppers, diners, and other foot traffic to the downtown Creekside District.

The City of Gahanna is proposing expansion of its Designated Outdoor Refreshment Area (DORA), known locally as the Creekside Outdoor Refreshment Area (CORA). The expanded boundary of the CORA commences at the northwest corner of the intersection of Granville Street and Mill Street, travels westerly to the eastern boundary of Big Walnut Creek, then continues northerly along Big Walnut Creek to 169 Mill Street's northern property line, then continues easterly along Carpenter Street's centerline to the intersection of Carpenter Street and Short Street, then continues south along the centerline of Short Street to the intersection of Short Street and Ogden Alley; then continues westerly along the centerline of Ogden Alley to the intersection of Ogden Alley and North High Street; then continues southerly along the centerline of North High Street to the northwest corner of the intersection of Granville Street and North High Street, then continuing westerly along the centerline of Granville Street to the point of commencement.

I certify that said boundary contains 27.02 acres, which is below the 320 contiguous acre requirement outlined in O.R.C. §4301.82(B)(1)(b) for a municipal corporation with a population less than 50,000.
