RE: Revised Proposal for Part 2 Engineering and Right-of-Way Services  
Hamilton Road/Granville Street Intersection Improvements

Dear Mr. Wetherholt:

Transmitted herewith please find our revised proposal to provide engineering and right-of-way services for the above referenced project in accordance with the Ohio Department of Transportation's Project Development Process (PDP) for Minor Projects, Steps 5-9. This proposal incorporates fee and scoping comments received from ODOT and subsequently negotiated through Mr. Lyle Flower of ODOT's Office of Consultant Services.

Services included in this proposal will serve to complete preparation of construction plans for the proposed improvements, prepare right-of-way plans and legal descriptions, provide right-of-way acquisition services to acquire all right-of-way needed for the proposed improvements, perform final staking of permanent right-of-way acquired as part of the project, and provide bidding assistance to the City of Gahanna.

The proposal includes a detailed breakdown of all tasks and associated costs. The following is a brief summary of costs for noted tasks:

It is anticipated that post-construction traffic services to optimize operation of the signal system will be required following construction of the proposed improvements. We propose to negotiate the scope of this work and associated costs at that time. No cost is included in this proposal.

We would also be pleased to provide construction services to the City, if desired. Costs for construction services are not included in this proposal, and would be negotiated prior to the beginning of construction.



Design services will be completed in accordance with the project schedule that has been established by ODOT, with tracings and right-of-way acquisition scheduled for completion by November 13, 2009.
