  - Most zoning districts don't have prohibited uses
    - If not specifically listed, use not allowed
- Zoning district determines allowed uses
  - 26 zoning districts
    - 10 residential
    - 16 commercial

- How are allowed uses determined for commercial zoning?
  - SIC (Standard Industrial Classification)
    - 11
  - NAICS (North American Industry Classification System)
    - 4
  - Uses not defined by other codes/plain English
    - 1
  - Prohibited use section that applies to all properties

### 1153.01 - SO SUBURBAN OFFICE AND INSTITUTIONAL DISTRICT.







- (a) Permitted Uses. Only the uses included under the following listed numbers or as otherwise specified in this district shall be permitted in the Suburban Office and Institutional District.
  - (1) Administrative and business. Administrative office primarily engaged in general administration, supervision, purchasing, accounting, and other management functions.

    Business offices carrying on no retail trade with the general public and having no stock of goods maintained for sale to customers.

- (b) Conditional Uses. The following uses shall be allowed in the Suburban Office and Institutional District subject to approval in accordance with Chapter 1169.

    - 8099 Health and allied services, not elsewhere classified.
    - 892 Nonprofit educational and scientific research agencies.
    - 899 Services, not elsewhere classified.

(4) Institutions.

829 Schools and educational services, not elsewhere classified.

835 Day care centers.

842 Arboreta and botanical or zoological gardens.

(5) Organizations and associations.

863 Labor unions and similar labor organizations.

869 Nonprofit membership organizations, not elsewhere classified.

(6) Public administration.

93 Public finance, taxation and monetary policy.

95 Administration of environmental quality and housing programs.

96 Administration of economic programs.

97 National security and international affairs.

(7) Family care home (as defined in Chapter 1123). The purpose of this section is to regulate the establishment of residential care facilities for individuals who are unable to live in their own home or with their family, are unsuited for foster home placement, or when foster home placement is unavailable and who are not in need of institutional care or treatment.

# Where's My Use Allowed

- Where's a vape shop allowed?
  - What is a vape shop?
    - Retail sale of tobacco
  - Depends if zoning district refers to NAICS, SIC, or plain English
    - NAICS 15 references
      - 453991 Tobacco stores
      - 4 different zoning districts allow use
    - SIC 19 references
      - 5993 Tobacco stores
      - 6 different zoning districts allow use
    - Plain English
      - Allowed if "retail" is allowed
      - 1 zoning district allow use
    - 11 of 16 commercial districts allow a vape shop

- What is the land use plan role in uses?
  - If zoning permits by right None
  - If conditional use Look at FLUM
  - If rezoning Look at FLUM
- Land use plan
  - Makes recommendations as to where uses should go
    - Very high level
      - Doesn't get into specific uses (few exceptions)
  - Makes recommendations on intensity, setbacks, height
  - Meant as a guide, not law
- Helps guide zoning code rewrite

- Zoning code rewrite
  - What has happened
    - Formatting, consolidation, eliminating obsolete code
      - Current zoning code has definitions in 10 different areas
      - New code will have one glossary
  - What hasn't occurred yet
    - What uses are appropriate in zoning districts
    - Where to locate zoning districts
  - Workshop 45-60 days out
