Re: Price Road Sanitary Sewer, Segments A-C

Dear Mr. Feltz:

I appreciated the opportunity to speak with you the other day about the sanitary sewer work needed for the City of Gahanna. The following is the Proposal for the Price and James Road Sanitary Sewer project.

#### INTRODUCTION

The project will consist of the design of a sanitary sewer along the back properties of both Price Road and James Road. There are no existing sanitary sewers for the properties along those roads and new lines will have to be installed to allow property owners to tie into the system. The area North and East of Price Road is very dense with shrubs and briar and may contain a possible wetland site. Further information will have to be collected and permits prepared to the appropriate authorities if a wetland is determined to exist.

For the properties east of James Road, easements will need to be obtained to run a line across the back of their properties. Also an easement will have to be negotiated for one of the home owners to run a line from the back of the property to James Road for the connection and elimination of an existing pump station located on the west side of James Road.


# SCOPE OF WORK

Segment A: Area running along Price Road.

Segment B: Area connecting the properties on the east side of James Road.

Segment C: Running sewer across one property on James Road via easement across to connect and eliminate the pump station on the west side of James

# OWNERS RESPONSIBILITIES

The Client shall provide the following information and services to GGC Engineers, Inc.:

- 1. Access to the project site during normal working hours.
- 2. All Permit Fees (EPA, State, County, City and any other).
- 3. Geotechnical needs
- 4. Photo geometric survey

### ENGINEERING BUDGET AND BILLING

GGC Engineers, Inc. will accomplish the work as outlined in the various segments above for a fee as follows:

#### **Survey Services**

GGC will provide survey services to determine elevations and property line boundaries for the sanitary sewer line design.

Seament C:

\$2,000.00

GGC understands that preliminary survey work has been performed by Geo One and Turner Surveying for the City of Gahanna. This consists of an aerial survey performed in March 2008. GGC has based the surveying costs on the assumption that the aerial survey is available and depicts the boundary and topographical dimensions of the area with the exception of the area west of James Road.

#### **Easement Services**

GGC will provide professional engineering services to prepare easement documents in order to tie in services under Segment C for a cost of \$720.00.

Design

GGC will to provide arrange and attend meetings with the City of Gahanna Engineering and Parks and Recreation Departments in order to coordinate sewer plans with City's desires and long-term goals of the Price Road property. Following discussions, GGC will prepare a preliminary alignment and review with the City's designated contact. Following City's review and approval, GGC will finalize design, technical specifications and submit to Ohio EPA for final approval. Approved Construction Documents will be provided to the City for bidding purposes for the segment fees of:
