## A. CALL MEETING TO ORDER - Roll Call:

Gahanna City Council met in Special Session on Monday, October 10, 2022, in Council Chambers. President of Council Stephen A. Renner called the meeting to order at 6:00 p.m. The agenda for this meeting was published on October 7, 2022.

## B. EXECUTIVE SESSION:

A motion was made by Weaver, seconded by Schnetzer, to go into Executive Session under authority of Section 5.40(g) of the Council Rules of Procedure to consider confidential information related to the marketing plans, specific business strategy, production techniques, trade secrets, or personal financial statements of an applicant for economic development assistance, provided that both of the following conditions apply:

- (1) The information is directly related to a request for economic development assistance that is to be provided or administered under any provision of Chapter 715, 725, 1724 or 1728 or sections 701.07, 3735.67 to 3735.70, 5709.40 to 5709.43, 5709.61 to 5709.69, 5709.73 to 5709.75, or 5709.77 to 5709.81 of the Revised Code.
- (2) A unanimous quorum of the public body determines, by a roll call vote, that the executive session is necessary to protect the interests of the applicant or the possible investment or expenditure of public funds to be made in connection with the economic development project.
