C. HEARING OF VISITORS:

Windy McKenna, Gahanna Jefferson School Board, stated she wanted to thank you all for the partnerships shared and for the good working relationship the school has with the City - the Transportation facility, support from the Police Department, the DARE program, the facilities we share including Hamilton House, the Lustron House, City Council Chambers, and meeting rooms, the Recreation Department's use of the school buildings and field facilities, the TIDE meeting which will be held at the district's new technology center at the High School, the school's participation in the TIDE program, and Student Government Day to name a few; thank all of you.

Gregg Morris, Superintendent of Schools, stated he was very appreciative of the way the City and District work together and the more we can do to work together the better it may be; proud of the way we do that in Gahanna; talk for just a minute on the Compensation Agreement between the City and the School District, it is not duplicated in the State of Ohio; serves our citizens well and certainly encourages development in the community and then shares the compensation that comes into the City through income tax which makes a win win situation for everyone; we have received 2 years of payments from the City and are somewhere in the vicinity of \$1.5 million received at this point; one of the things want to share with you is that our community was gracious enough and supportive enough in 1998 to pass additional resources for the School District; told them at that time that we would implement our strategic plan which meant 36 more teachers, meant additional facilities, meant additional training for staff; meant additional technology; told them we would do that and we would stay off the ballot for 4 years already extended that to 5 years; these additional resources will become part of that extension; we can stay off at least 5 years from passage of last issue; hope even longer; very anxious to know what is happening with Lucent and State of Ohio; this agreement and our working together has enabled us to do that for our community; think you should be proud of that; thank White for her efforts in development; when we started this discussion Mayor McGregor and Angelou were involved; Payne and Kneeland came in to be supportive and help us to get off some of the difficult obstacles we were addressing; was a very complicated process; we were able to accomplish it and

we all should be very proud.

Kneeland stated we all sit and look at what we believe are the best accomplishments that anyone could wish for but the true winners here are our kids; that's the ultimate goal and we probably have some of the best partnerships in the State and even the country; kids will be the ultimate winners in this opportunity; appreciate the possibility of working in conjunction with the schools over the years.

Stinchcomb stated that is wonderful news to the taxpayers that they will stay off the ballot for another year; does speak to the value of partnership; thank you for sharing.

PUBLIC MEETING - LLEBG Grant

President opened Public Hearing at 7:35 p.m.

Dennis Murphy, Chief of Police, stated the purpose of presentation this evening is to inform Council and the public that for the fourth consecutive year, the Gahanna Police Department will receive a grant from the Local Law Enforcement Block Grant based on the year 2000 Uniform Crime Report (UCR). Our UCR reporting makes the department eligible to receive \$12,422. A matching fund of \$1,380 is required and will be drawn from the Law Enforcement Trust Fund. A Request for Council Action has been forwarded to Council for approval. Pursuant to the guidelines of the grant, I convened an Advisory Board consisting of Mayor Jim McGregor, City Attorney Tom Weber, School Administrator Dale Foor, Villages of Gahanna Civic Association President Bob Stallings and Deputy Chief of Police Larry Rinehart. The purpose of the board was to make nonbinding recommendations for the proposed use of funds. The advisory board concurred with my recommendation to use the grant money to pay overtime for the prevention and investigation of violent or serious crimes in the City of Gahanna. I intend on using money to pay overtime to our patrol officers, detectives and Community COPs, who through their team efforts have done an excellent job both preventing, investigating, and prosecuting violent crimes in our City. I am prepared to answer any questions pertaining to the grant at this time.
