#### **ACTION ITEMS**

# ACTION ITEM #1: 2025 STREET REBUILD AND WATERLINE PROGRAM, ST-1116 – AWARD OF CONTRACT

The 2025 Street Rebuild and Waterline Replacement Project (TR-CM-02) will be conducted on Laura Dr, Heil Dr, and Rocky Fork Blvd. This work will consist of waterline replacement, stormwater improvements, new curb and gutter, sidewalk work, roadway base and asphalt along portions of the roadway.

On October 30, 2025, bids were opened and reviewed. In total, seven (7) bids were received. Elite Excavating Company of Ohio, Inc. was the lowest responsive and responsible bidder. The Administration is recommending awarding Elite Excavating Company of Ohio, Inc. the construction contract for this project.

A total of \$2,995,001.68 is required for this contract which includes acceptance of an alternate bid to use high recycled asphalt (\$123,471) and a 10% contingency (\$272,272.88) to cover any unforeseen costs. Funding for this project was allocated and approved by Council in the 2025 Capital Budget and no additional funds are required.

The Administration respectfully requests an ordinance authorizing the Mayor to enter into contract with Elite Excavating Co. of Ohio, Inc. for the 2025 Street Rebuild and Waterline Program, ST 1116.

## <u>ACTION ITEM #2: TAYLOR ROAD WATER MAIN REPLACEMENT PROJECT- ST-1121 - AWARD OF CONTRACT</u>

The Taylor Road Water Main Replacement Project (WA-24-01) will replace the existing 12-inch water main, which was installed in 1964, with a new 16-inch line and will include related improvements (valves, hydrants replacement, site restoration, etc.). This replacement will take place between Morrison Road and the City's pump station at Helmbright Rd. In addition, residential sidewalks will be brought up to PROWAG standards per the City Code.

On November 20, 2025, bids were opened and reviewed. In total, seven (7) bids were received. Shelly and Sands, Inc. was the lowest responsive and responsible bidder. The Administration is recommending awarding Shelly and Sands, Inc. the construction contract for this project.

A total of \$2,543,207.48 is required for this contract which includes a 10% contingency of \$231, 200.68 to cover any unforeseen construction costs. Funding for this project was allocated and approved by Council in the 2025 Capital Budget and no additional funds are required.

The Administration respectfully requests an ordinance authorizing the Mayor to enter into contract with Shelly and Sands, Inc. for the Taylor Road Water Main Replacement Project ST-1121.
