# ACTION ITEM #1: ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO JOINT SELF INSURANCE AGREEMENT

In order to continue as a member of the Central Ohio Health Care Consortium (COHCC), the City must enter into the Joint Self-Insurance Agreement as part of the three-year trust cycle. The next three-year trust cycle goes into effect January 1, 2025. An Emergency is requested in order to secure necessary signatures to ensure that employees' health benefits continue without interruption. Attached to this report is a red-lined version of the agreement, as well as one with the changes accepted.

Rates for the 2025 Plan Year have been set and approved by the COHCC Board. Health insurance premiums for 2025 will increase by 1% over 2024 rates.

The Administration respectfully requests Council to issue legislation authorizing the Mayor to sign the Amended And Restated Central Ohio Health Care Consortium (COHCC) Joint Self-Insurance Agreement.

# ACTION ITEM #2: ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO CONTRACT WITH THE BOARD OF HEALTH OF THE FRANKLIN COUNTY GENERAL HEALTH DISTRICT (FRANKLIN COUNTY PUBLIC HEALTH) FOR 2025 PUBLIC HEALTH SERVICES

The City of Gahanna contracts with Franklin County Public Health (FCPH) to provide public health services for the City and to function as the City's public health department. FCPH's services include administrative services, data services, environmental health, emergency preparedness, epidemiology, health promotion, health systems and planning, immunization services, occupational health, inspection services, and maternal and child health. The cost of the 2025 program is \$354,273.05 (\$10.1867 per capita). This represents a ~1.4% increase from the 2024 contract.

The Administration respectfully requests legislation authorizing the Mayor to enter into contract with Franklin County Public Health for 2025 health services. This includes a request for an Emergency to ensure the contract is signed for a January 1, 2025, effective date and to ensure continuity of services. The Administration received the contract from our partners at FCPH on October 9, 2024.
