Karl Wetherholt, City Engineer, stated we are presenting changes to Chapter 1193 and Chapter 1195 of the Codified Ordinances; Chapter 1193 is the Stormwater Management Policy and Chapter 1195 is Sediment and Erosion Control; adding to that post-construction management procedures; these two sections are very old; last updated in early '90s; have been many changes in the industry; clarifications for the calculations and engineering of those types of projects have been updated with new technology and EPA regulations require us to be in compliance with what Ohio EPA has in their guidelines; that necessitated these changes; Service Department and various others decided that this was a good chance to update the entire chapter to make it modern for 2010; now have the proposed modifications which have been recommended to Council through Planning Commission and ready for the ordinance to be codified. President asked for opponents. There were none.

L. REPRESENTATIVES:

Community Improvement Corporation (CIC) - Ewald/Kneeland:

Kneeland stated he attended last week; changed meeting dates to second Tuesday; is a conflict of a couple of months that are noted in the schedule; in process of beginning to look at strategic goals identified during our goal setting sessions; are setting priorities; number of projects in process.

Mid-Ohio Regional Planning Commission (MORPC) - McGregor:

McGregor noted meeting was last week; was unable to attend.

Bd. of Education, Gahanna-Jefferson Public Schools - Ewald:

Ewald thanked Mounts for his report; meeting was pretty much organizational; lot of legislation on contracts etc; one thing I took away is that Jefferson Elementary is introducing technology in classroom in a way that hasn't been done; have new technology at Jefferson; students can view a screen and move ideas around on board; that technology is being adopted throughout central Ohio; interesting to watch the pilot program and see it adopted by others throughout the state; Gregg Morris was awarded the Superintendent of the Year for the state.

Convention & Visitors Bureau (CVB) - Kneeland:

Kneeland assigned himself as the representative to the CVB for this year; did it several years ago; couple of things CVB did at last meeting; board is currently considering analyzing concept of hiring a firm to do fundraising; to move to next level this will be important; also looking to move to another location; there is the possibility they will be moving; more to come on that; they voted to increase the Blues &Jazz Festival admission from \$2 to \$3; does cost staff time and internal funds to make that work;

Anderson was also at that meeting; web site is still a work in progress; let them know if you have suggestions or praises; look forward to it being up and running shortly.

Stinchcomb stated that the Parks & Recreation Foundation Gala is on February 6; deadline for tickets is quickly approaching; like to have your support; proceeds support Camp Friendship scholarships; meet with Morris every couple of weeks; he did ask me to let Council know that February 1 is the State of the Schools address at 6:30 p.m.

McAlister noted we have a Boy Scout in the audience; asked which badge he was working on and the reply was Communications Badge; wish you well and thank you for coming.

McGregor stated she wanted to note a Channel 10 report on Elaine Angell Missionary Lifeline out of Westerville; has gone for 10 or more years to Haiti; her husband was our part time code enforcement a couple of years ago; see interview on Channel 10 website; can read those interviews; interesting to know someone who was there; appreciate invocation for service personnel; having my son there for 2 years out of the 5 makes me appreciate it; know it is appreciated by all.

Anderson stated she wanted to underscore comments about Lifeline; donate time to Lifeline as part of our international service; deals with an orphanage in Haiti; can go to Channel 10 to hear interview; one of many orphanages that are having challenges; also informed by YMCA that this Thursday at 7:00 p,m. they will be having a health screening; come out to the Y at 7:00 p.m.

Evers stated it has been noted but please keep victims of earthquake in thoughts; do have a brief announcement; have taken a new position and as a part of that will be relocating to Washington DC; have very mixed emotions; will be resigning at the end of February my Ward 3 Council seat; want to take this opportunity to thank residents of Ward 3; has been my honor to serve for these 6 years; gotten to know many of them; also thank my peers on Council, the Council staff and the administration; this is a new chapter in Evers family life; thank everybody and thank city employees for 6 wonderful years.

Samuel wished Evers well in future endeavors; was near Haiti last week and am glad and thankful I live in this country; very sad some things I observed; did have 85 degree weather; Service Department again did a great job on streets.

Ewald echoed prior comments; has been a pleasure to work with Evers; one thing like to say is that you always knew where he stood; enjoyed working with you and feel we accomplished a lot under your leadership; second comment is regarding Haiti relief; lot of organizations were there before and are there now; encourage you to donate; even in these economic times if you can't give monetarily or canned goods, your time is valuable in any relief effort; encourage your families and friends to donate and get involved.;

Kneeland stated he was surprised by announcement tonight; has shown a great tenacity in doing his private job as well as being a colleague; appreciated his insight in a lot of things; save my comments for later in the month of February; will miss your
