Dispatch Sgt. finally got back to me with the number of calls for service. Since 2000 there has been 563 calls for service at 2611 Wayne so roughly 35 calls per year. Re: Access Energy facility
Date: January 30, 2017

On Friday January 27, 2017 Detective Thomas and I drove to the Access Energy Rehab facility at 2611 S. Wayne Ave in Dayton, Ohio. Detective Thomas took several pictures of the facility from various angles to capture the proximity of houses in the area. The facility does look like an old hospital and as such, has a lot of open grassy area surrounding it. To the rear of the facility is a high school track which is approximately 50 yards from the rear parking lot. The high school itself is a short distance away from the track and Access Energy. The best way to describe the distance relationship would be our police department in relation to the high school with the track being by the senior center.

Detective Thomas and I spoke with the East Patrol Operations Division Detective Sergeant Matthew Beavers at his substation. He relayed to us the following estimated stats:

- 75% of the runs to the facility are medical to include drop offs, pick up and emergency admission forms (pink slips).
- There were a few instances of thefts to include stolen money in the facility
- Warrant arrests
- Mental health calls
- Telephone harassment
- Patient threatening staff with a shard of glass
- Assaults on staff by patients

Sgt. Beavers was asked if his sub is constantly going on calls to the facility and he indicated no. He furthered that the drain on police resources was due to driving patients to court dates, doctor's appointments and other appointments. He cautioned that our department should find out what requirements, if any, our facility will expect of us in this instances. He also wanted us to find out what type of security the facility would have and if it would be staffed by a security guard.

Sgt. Beavers stated the biggest problem we would face would stem from the in and out of patients not required to stay there. He cited domestic violence situations, people attempting to bring in contraband and OD's. Sgt. Beavers did not give the impression the facility had a substantial drain on the police resources.
