Welcome to the 2023 Gahanna Capital Improvements and Investments Feedback form for the City Council of Gahanna.

The City's planned spending related to capital projects will be guided by the Capital Improvement Plan (CIP) The CIP will be introduced by the Administration to City Council in April 2023. This will kick off in-depth review of the Plan by Council and the public, which will be formally voted on and adopted later in the year. The CIP will be used in conjunction with a Parks Master Plan that is under review, and the Land Use Plan that was adopted in 2019. These documents together inform the City's annual budget.

Capital projects relate to physical assets such as roads, sewer and water infrastructure, parks and recreational facilities, and municipal buildings. We know these capital investments are vital for supporting residents' quality of life and our local economy. Issue 12 funding continues to have a monumental impact on the City of Gahanna's ability to not just improve the quality of services, but also to invest in infrastructure for our current and future residents.

However, these projects and money spent on them must align with residents' needs. We hope you'll share input on the capital needs you see in Gahanna using this form. **As you share information with us, please do your best to be specific about the locations associated with the needs or opportunities you see.** This will empower City Council and departments to do the most with your input.

After its introduction this Spring, the CIP will be discussed and considered for adoption by Council later in the year. City Council will hold XX public hearings on the CIP at City Hall which will be streamed on the [City's YouTube channel](#). Public Hearings participation can be in person by attending the meetings or by submitting a video (no more than 3 minutes in length) via this [link](#).
