Report to Council

The following report provides an overview of performance data compiled by the Division of Police for August, 2018.

Emergency Communications:

- ↳ Dispatchers handled 404 9-1-1 calls throughout the month. The average call answer delay remained at four seconds per call.
- ↳ 37.7% of all 9-1-1 calls received by the Communications Center originated from cellular phones while 17.8% were received from VOIP (Voice over Internet Protocol) telephone lines/systems.
- ↳ An additional 3,958 calls were received through the Division's non-emergency lines. Year-to-date, the Communications Center has processed 29,978 calls through non-emergency lines.
- ↳ 2,798 calls for service were dispatched in August.

Patrol Operations:

- ↳ 304 offense and arrest reports were generated including a summary of the following incidents by type:
 - 19 Theft from vehicle reports in which entry was gained almost entirely through unlocked doors. Two suspects were arrested and warrants have been issued for three additional suspects.
 - 16 Criminal damaging incidents with one arrest and a warrant issued for a second suspect.
 - Two robberies of gas stations occurred on the same day involving the same suspect.
 - Nine Burglaries were reported with three occurring at the same residence involving items being removed from the home of a deceased tenant.
 - Two reported misdemeanor assaults (no domestic nexus).
 - Domestic-related responses include:
 - 24 documented disputes that did not involve a criminal offense.
 - Seven incidents resulted in arrests for Domestic Violence with two additional cases in which warrants were issued.
 - One domestic incident was referred for further investigation/prosecutorial review.
 - Seven responses to overdoses occurred in August. None of the responses involved fatalities. Heroin was suspected in three of the incidents with four involving prescription medications.
- ↳ The Division responded the following drug offenses:
 - Drug/narcotics offenses – five incidents including two offense reports and three arrests.
 - Drug Equipment violations – four incidents including one offense report and three arrests.
- ↳ Officers conducted 920 traffic stops with 378 traffic violators issued citations and an additional 17 arrests were made as a result of the stops.

- ↳ The Division responded to 42 motor vehicle crashes with a further breakdown as follows:
 - 34 were classified as property damage only (PDO) or 80.95% of all responses.
 - Eight crashes involved injuries or 19.05% of all responses.
 - No fatalities occurred
 - Ten crashes occurred on IR-270 – 23.8% of all crash responses in Gahanna.
 - No crashes involved alcohol and/or drug impairment
 - No crashes involved pedestrians or bicyclists
- ↳ Patrol officers affected eight arrests for impaired driving (OVI).
 - Four of the arrestees refused to submit to chemical testing.
 - Four arrestees submitted to chemical testing – either breath or fluids.
 - The high test for the month was 191.
- ↳ The Division received and subsequently responded to 132 alarm calls in August. All of the responses were determined to be false. A total of \$3,100 in false alarm fees were billed to permit holders. Year-to-date the Division has billed permit holders \$31,500 in alarm fees. Thirteen new alarm permits were issued during the month.

Detective Bureau:

- ↳ The Division’s detectives were assigned 109 offense and arrest reports requiring investigative follow-up or other administrative action.
- ↳ The detectives obtained nine investigative subpoenas and executed an additional six search warrants during the month of August.
