### ACTION ITEM #1: RESOLUTION TO ADOPT REVISED ELECTRIC VEHICLE CHARGING STATION FEES

In accordance with Chapter 949 of the Gahanna Codified Ordinances, the Director of Public Service sets, and Council adopts, the rates for Electric Vehicle Charging Stations. Gahanna has two types of EV Charging Stations: Level 2 Stations (L2) located at City Hall, Friendship Park, Hannah Park and the Municipal Golf Course, and DC Fast Chargers (DCFC) located in the Creekside Parking Garage and the Municipal Parking Lot.

To align with known increases in the City's supplier costs, the following rates are recommended for the stations, beginning December 8, 2025:

- Level 2 (L2) stations at \$0.30 kWh (a \$0.02/kWh increase)
- DC Fast Charger (DCFC) stations at \$0.40 kWh (a \$0.01/kWh increase)
- Removal of idle fees

Based on the above, the Administration respectfully requests a Resolution to adopt fees per Chapter 949 of the Gahanna Codified Ordinances as outlined above.
