General Update:

June 2020 was a critically important month, with dozens of demonstrations drawing hundreds of residents to condemn racism and instances of brutality. This dialogue dominated constituent attention, though the important issues around COVID-19, reopening, masks and social distancing, and school policy also continued to be discussed.

I reinstated Constituent Hours on June 15. We met outside of the Gahanna Senior Center, with three members of the public attending in person, and four members attending via Zoom. I will continue to hold Constituent Hours in this manner on July 6 and July 20.

Constituent Issues/Concerns:

#1: Police Reform, Black Lives Matter, Police Safety, Community Policing Action:

- Released policy statements;
 - Attended citizen-led demonstrations;
 - met with Mayor, City Attorney, Directors, Chief and Deputy Chief of Police on June 10;
 - Phone calls, emails, and conversations with neighbors and constituents;
 - held Constituent Hours on June 15, most of discussion regarding police policy, safety;
 - held Discussion on 21st Century Policing with central Ohio lawmakers and attorney Raphael Davis-Williams of the ACLU of Ohio

Response:

Will continue to work with colleagues and Chief of Police to discuss opportunities for advancing 6 Pillars of Community Policing. Policy proposals to be discussed with stakeholders. Over 950 views of virtual Discussion on 21st Century Policing as of this Report; statement regarding Discussion attached.

#2: Access to City Council Meetings/Public Comment Received feedback from constituents primarily on social media that questioned the continued virtual city council meetings and lack of public comment.
