To Whom it May Concern,

I am writing in regard to the One Church application for Development Plan, Design Review, and Variances of their parking lot.

I am concerned about the amount of parking required by One Church. This already large lot would become even more massive and take up a majority of their property. This is extremely unsightly and incentivizes the use of individual vehicles and driving to the church. As a city, Gahanna should be helping everyone to drive less to decrease the effects of climate change, increase pedestrian safety and the general appeal of the city. If possible, I'd encourage One Church to start a carpool sign up or since they are so large to start a bus pick up service where they could pick up members of the congregation with a church-owned bus. This would also help those with accessibility needs like the elderly or who can't drive to attend the church.

I am also concerned by One Church's request for a variance on landscaping for the parking lot. Trees and landscaping spread out across the lot help with absorb water runoff, provide shade, and induces traffic calming all of which are desperately needed in a lot of this size. Traffic calming especially needs to be considered here due to the extreme size of the lot for pedestrian safety. The trees would encourage drivers to slow down and make them more aware of their surroundings. Landscaping in the parking lot will also discourage possible safety dangers when the church isn't in session like those who would like to use the lot to try to do driving stunts like donuts.

In addition to safety and environmental reasons, landscaping would be much more pleasant to look at than an entirely empty lot a majority of the week. Gahanna is a city for people, not cars. We should be encouraging all businesses and organizations with property to minimize parking and car traffic as much as possible.

I understand that Planning Commission must approve things that are legally allowed but I ask the Commission to consider what is best for the city and to ask One Church if they have considered other options instead of a massive empty parking lot. And if One Church hasn't then please as the Commission encourage One Church to seek out other options that would be better for Gahanna and their congregation's future.

Please do not approve the development plan as it with so many parking spaces. And if you must then please bring this problem of allowing so much parking to the zoning department for consideration to change.
