**WHEREAS**, the 2022 Lincoln Lions bested Lancaster, Hilliard Bradley, Pickerington Central and New Albany in post season play, placing them in the State Division 1 semifinal game; and

**WHEREAS**, the 2022 Lincoln Lions valiantly battled powerhouse Lakewood St. Edward in a repeat competition of these two teams last meeting in a state semifinal in 1976; and

**WHEREAS**, though they lost in the semifinal game, these fine young men and their coaches and parents are to be commended for a wonderful, exciting, and successful season.
