

DESCRIPTION FOR ZONING

0.926 OF AN ACRE

Situated in the State of Ohio, County of Franklin, City of Gahanna, located in part of Quarter Township 3, Township 1, Range 16, United States Military District, being part of that 1.0 acre tract of land described in the deed to the City of Gahanna, recorded in Instrument No. 200106220141678 (record references recited herein are to those of the Recorder's Office, Franklin County, Ohio), and being more particularly described as follows:

Beginning at the intersection of the northerly right-of-way line of Taylor Road, with the easterly line of said 1.0 acre tract, being in the westerly line of those lands described in the deed to United Baptist Church of Columbus, recorded in Deed Book 3257, Page 535;

thence westerly along said northerly right-of-way line, being a line 40.00 feet northerly of, as measured perpendicular to and parallel with, the centerline of said Road, North 85°52'01" West, 80.90 feet to the westerly line of said 1.0 acre tract;

thence northerly along said westerly line, North 3°29'59" East, 498.44 feet to the northwesterly corner of said 1.0 acre tract;

thence easterly along the northerly line of said 1.0 acre tract, South 85°52'01" East, 80.90 feet to the northeasterly corner of said 1.0 acre tract;

thence southerly along the easterly line of said 1.0 acre tract, South 3°29'59" West, 498.44 feet returning to the 'Point of Beginning,' containing 0.926 of an acre of land, more or less, as described in June of 2008, by Carl E. Turner Jr., Professional Surveyor No. 6702, from existing records for zoning purposes only.

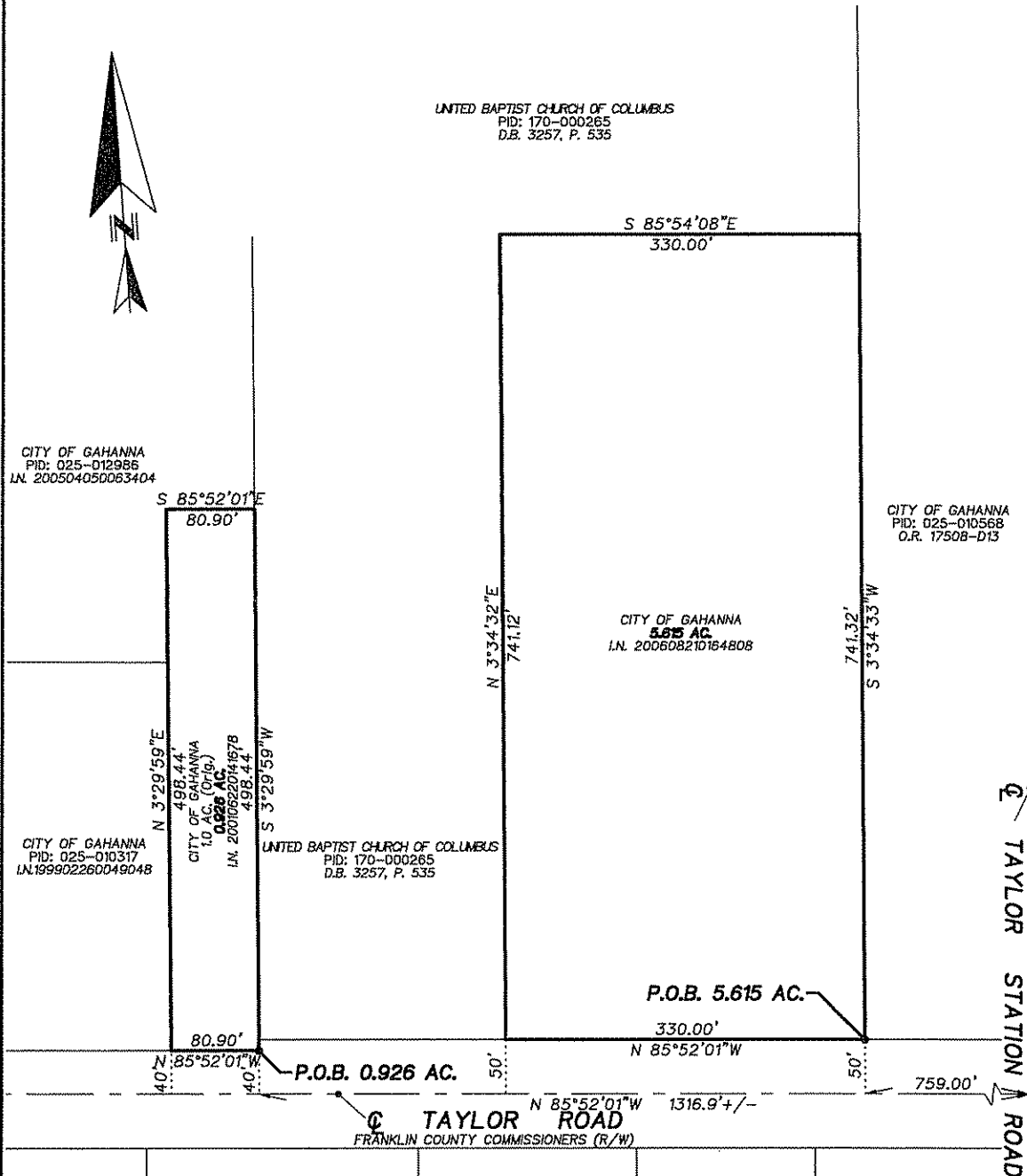

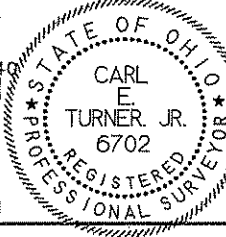
