The City of Gahanna, Ohio ("City"), and David A. Antrim ("Contractor"), hereby agree as follows:

(1) In exchange for consideration herein stated, the Contractor agrees to provide personal services as Project Manager of the Foundation Drain Rehabilitation project. The duties of the Project Manager shall include, but not be limited to the following:

- (a) Setting up appointments between residents and the plumbing contractor for initial meetings.
- (b) Coordinate construction dates and times.
- (c) Keep records of all construction done on the project, including pictures showing existing and completed conditions.
- (d) Handle all phone calls from residents with complaints and/or questions.
- (e) Keep the project on schedule and report to the Service Department any delays and reasons for same.
- (f) Resolve conflicts which may arise before, during and after construction.
- (g) Prepare periodic progress reports and a final report for the Foundation Drain Rehabilitation Project.

(2) In consideration for providing the said personal services, the Contractor shall be compensated at the rate of \$25.00 per hour. The Contractor shall receive payment by check, for services rendered, on regular paydates, provided a statement of hours worked has been submitted to and approved by the Director of Public Service.

The aggregate total of all compensation under this contract shall not exceed \$15,000.00.

(3) The personal services provided in this contract shall be for a period of six months with month to month renewal, if needed.

(4) The Contractor shall pay all City Income Taxes due or payable under the provisions of Chapter 161 of the Codified Ordinances of Gahanna (as amended) for services performed under this contract.

(5) This contract shall be subject to immediate termination by the City when the City has exhausted all funds legally available for all payments due under such contract.

It is further agreed that the City, upon giving the Contractor seven (7) days advance notice, may terminate this contract for any reason during its term, and shall have no other financial obligations under the contract thereafter.

(6) This contract is for independent personal services and is not a contract of employment.
