M. COUNCIL COMMENT:

Hogan stated he thanked Weber for making recommendations on changes to the fence code; feel we have real issues there; are a lot of inconsistencies; have people who have been turned down even though deed says they can have a fence; other people have been given variances; really a mess; we are way out of compliance in terms of storm water management and other things; really need to be reviewed; thank Weber for doing that.

Angelou also thanked Weber for looking into fence code and perhaps making changes to make it more understandable for our citizens; thank Development Department, Parks & Recreation, Service as well as the Police Department for everything they did to make Creekside memorable; too bad rain didn't hold off so we could get in the 2nd half of jazz orchestra; vendors were there for a long period; ran into a medic when in the fire house and he thought there were about 20,000 people between Friday and Saturday; keeps getting bigger and bigger; thank you all for your hard work. employees in this City are quite amazing.

Payne stated it was a great festival; was there Friday night instead of Saturday; also the Relay for Life was a great event; decided on the spur of the moment to come out and support O'Brien and Stinchcomb in their walk; enjoyed that stroll early in the morning; appreciate Froman's work on that.

Kelley also thanked everyone for their hard work; offer my condolences to Dan Williams; is a terrible tragedy; heart goes out to their family.

O'Brien stated there is so much joy in our community but that joy was dampened this weekend; from a personal point, things like this happen and make us realize we are all individuals; all have issues and we are marching to our own tune; are all brothers and sisters and we all hurt for the Williams family; makes me realize that I care about all of you - staff and colleagues on Council; when someone hurts we all hurt; saw some amazing efforts this weekend; saw the community come together; was a sad time but a time to bring us together; continue to pray for Danny; thank all staff for fine job at Creekside; celebration was wonderful; ribs were great; was pleased and honored to participate in the Relay for Life; appreciate company around the track at 1:00 am; understand that \$100,000 raised by the Relay; also congratulate seniors including our WWII veterans who received their diplomas earlier this spring; schools continue to do a fine job.
