Murdock said Olde Gahanna emotes a certain feeling of how it should look and what contain; looking to add style, theme and continuity and focus to the downtown district; special place; heart of Gahanna; need to protect and guide designs of the area. The team felt it was important to clean up the code; use illustrations; how make it work; landscape; 34 pictures. They are asking for adoption of the guidelines as proposed.

Kelley said he has two concerns; neon and menu boards; especially neon; do we really need neon. White said there are some cases where neon is appropriate, such as a drive in restaurant; not want to prohibit it, but the Planning Commission is not going to lean to it often.

There was discussion about changing wording on page 5-5 which states that neon is permitted in small quantities. Weber was proposing wording, and White said she would come up with several phrases and get them to Council for before Friday. The ordinance will have to be amended by substitution to make change.

It was stated that ordinances 92, 93, 94 and 95 are a package.
