WHEREAS, in 2016, the Oakhaven Garden Club began working on gardens around the 1869 one room school house located at Lincoln Elementary; and

WHEREAS, the Oakhaven Garden Club helps the community through active participation; and

WHEREAS, gardening is an activity that anyone in the community can enjoy and Oakhaven Garden Club makes a world of difference in the Gahanna community where people reside and work; and

WHEREAS, the Oakhaven Garden Club has reached a milestone that all members should be very proud; and

WHEREAS, Gahanna values its many service clubs and all that they do for our community and we appreciate everything the Oakhaven Garden Club has done for the City of Gahanna and the community over these last 60 years.
