## ITEMS FROM THE CITY ENGINEER

1. <u>MR-0001-2016</u>

MOTION RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE PERMISSION TO BID THE 2016 STREET PROGRAM ST 1039 / DETROIT STREET REBUILD ST 1039.

Priestas said this street program will consist of asphalt resurfacing, crack sealing, including Detroit Street rebuilds on various streets; said the annual street evaluation and rating has been completed; will provide the list when it is finished being developed; requesting a Motion Resolution to bid the program; McGregor asked if there was an idea of the build they would do; Priestas said Amesbury Way is a big plan for this year.

**2.** MR-0002-2016

MOTION RESOLUTION TO AUTHORIZE THE DIRECTOR OF PUBLIC SERVICE TO BID THE CARPENTER ROAD BRIDGE REPLACEMENT ST 993.

Priestas said the bridge is in need of replacement; design will be complete by the end of the month; Leeseberg asked if Heil was on the list; Priestas said hopefully 2017 replacement; Larick asked if there was a list of capital items and their condition; Priestas said their bridges are rated annually as required; Larick asked if the list was

published; Priestas said unsure if it was published to the website but we can do that; Angelou asked about US-62 between Carpenter and Cherry Bottom Road; said it is getting worse; Priestas said they are pushing to get that completed this year as emergency maintenance; see the need for the work to be completed immediately; Schnetzer confirmed the resurfacing was up to the intersection at E Johnstown and Hamilton; Priestas said it should be back on the schedule this year.

**3.** MR-0003-2016

MOTION RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO BID THE CLAYCRAFT GENERATOR BOOSTER STATION ST 1039.

Priestas said if there is a loss of commercial power the booster station will not function; the City experiences numerous interruptions of commercial power; want to have redundancy and reliance; request a Motion Resolution to bid the project; Angelou asked the cost; Priestas said \$175K is the current estimate; Kneeland said it would be paid for out of the proprietary fund.
