Planning & Development Department Action Items:

Office & Industrial Incentive for Grote Company

The goal of providing an Office & Industrial Incentive is to encourage private investment and job creation opportunities within the commercial corridors of the City of Gahanna. <u>The Department of Planning & Development (Department) is requesting that City Council authorize the Mayor to enter into an Office & Industrial (O&I) Incentive Agreement for Grote Company.</u>

Project Summary & Justification

In the late 1960s, Jim Grote, founder of Donatos Pizza, created the Peppamatic, the world's first automated pepperoni slicer/applicator. The Peppamatic's unique ability to cut labor cost, while increasing productivity and efficiency, inspired Mr. Grote to found the Grote Company. Since 1972, Grote Company has established itself as the world leader in slicer/applicator innovation and technology and continues to revolutionize the way food processors and manufacturers slice, stack, portion, count and arrange virtually all types of food products. Grote currently has 100 employees within The Industrial Zone of Gahanna.

The Grote Company recently acquired a company called Pizzamatic. This company is a food processing equipment manufacturer located in South Holland, Illinois. The Grote Company has an option to maintain the production facility in Illinois or to move the production lines to their Gahanna facility. In order to help secure the expansion project within the City of Gahanna, the Department is requesting to provide an O&I Incentive for the project. In addition, the state of Ohio is proposing to provide a Job Creation Tax Credit for the project.

Budget Impact

The Grote Company is proposing to create 13 new full-time positions at their Gahanna facility. These positions will have an annual salary of \$53,846. The project will require \$100,000 in building modifications and an additional \$750,000 for machinery and equipment. A financial incentive is a major factor in the Grote Company deciding to move forward with this project in Gahanna.

The Department is proposing to provide a 5 year 35% O&I Incentive on the new jobs stemming from the project. The Incentive Advisory Board will be meeting on Tuesday, October 13th and will be voting on whether to recommend that City Council provide the Grote Company with this financial incentive.

The total estimated incentive payment to the Grote Company would be \$18,375 over five years. The net income tax revenue to the City from the new jobs would be \$86,625 over 10 years. A detailed project summary is attached.
