# ACTION ITEM #1: STREET SWEEPING AND PARKING GARAGE CLEANING SERVICES – AWARD CONTRACT

On November 19, 2021, bids for the street sweeping and parking garage cleaning services contract were opened and reviewed. The lowest and best bidder is SCA of OH, LLC (Sweeping Corporation of America). The bid price is \$105,580 per year. The term of the contract is for three (3) years, commencing January 1, 2022 and ending December 31, 2024, with the provision for two (2) separate consecutive renewals of one (1) year each. The bid summary and a copy of the proposed contract are attached for your review.

## ACTION ITEM #2: 2022 STREET REBUILD AND WATERLINE REPLACEMENT DESIGN – AWARD CONTRACT

The Department of Public Service and Engineering is requesting an ordinance authorizing the Mayor to enter into contract with GPD Group for professional services associated with the 2022 Street Rebuild and Waterline Replacement Design project.

This project will design roadway and utility improvements to Heil Drive between Mill Street and Shull Avenue, Laura Drive between Heil Drive and Jennie Drive, North Street between High Street and Shepard Street, River Drive between James Road and Parkland Drive, and Rocky Fork Drive North between Flint Ridge Drive and Cliffview Drive. Engineering services are needed for the design of these streets due to the complexity of the rebuilds and number of utilities that need to be replaced or improved.

Construction of these streets is expected to occur in 2023. In addition to pavement reconstruction, sidewalks, utilities, and drainage features will be added or improved with this project. Copies of the proposed contract and proposal are attached for your review.
