The "COLLECTION BID AND USE OF BLUE RECYCLABLE MATERIAL COLLECTION CONTAINERS" is described as follows: The City/Collection Contractor shall provide each Residential Unit with a blue colored unbranded collection container for Recyclable Materials at the prices submitted above.



**City/Contractor Provided
Recycling Containers**

Each Residential Unit shall be supplied with a wheeled, blue colored, unbranded Recyclable Materials collection container of 48, 64 or 96 gallon capacity subject to the implementation plan. Additionally, the Participating Communities will allow Residents to rent or purchase an additional Recyclable Materials collection container.



**Resident Provided Collection
Containers**

All Residents must supply their own Solid Waste collection containers. The volume of Solid Waste placed curbside for collection by each Residential Unit shall be unlimited, and shall include collection of Bulk Items. Collection of Bulk Items shall be on each regularly scheduled collection day. Bulk Items are defined in Exhibit A. Bulk Item collection does not include additional household Solid Waste that simply exceeds the capacity of the Resident's selected collection container and does not included collection of a Judicial Set-Out Order/Eviction.

The “COLLECTION BID AND USE OF COLLECTION CONTAINERS” is described as follows: **The City or Collection Contractor provides each Residential Unit with two wheeled collection containers at the prices submitted above; one black, brown, or gray for Solid Waste and one blue for Recyclable Materials.**



It is anticipated that the standard size for Recyclable Materials collection containers will be 64 gallons. However, the Participating Communities will allow Residential Units to choose a 96 gallon Recyclable Materials Collection Container.

Bidders shall submit: (1) The per Residential Unit per month bid price for Collection Contractor to provide collection, transportation and delivery for disposal and processing of Solid Waste, Recyclable Material, and Yard Waste; and (2) The additional costs of the Collection Contractor providing each Residential Unit with Solid Waste and Recyclable Materials collection containers and the Collection Contractor retains ownership of collection containers at the end of the five (5) year term; and

The additional costs of the Collection Contractor providing each Residential Unit with Solid Waste and Recyclable Materials Collection containers and the City/Township owns the collection containers at the end of the five year term. If Option 3 is selected, the Collection Containers shall be unbranded except that they shall be clearly identified as either a Solid Waste container or a container for Recyclable Materials.

The “COLLECTION BID AND USE OF COLLECTION CONTAINERS” is described as follows: **The City or Collection Contractor provides each Residential Unit with two wheeled collection containers at the prices submitted above; one black, brown, or gray for Solid Waste and one blue for Recyclable Materials.**



It is anticipated that the standard size for Recyclable Materials collection containers will be 64 gallons. However, the Participating Communities will allow Residential Units to choose a 96 gallon Recyclable Materials Collection Container.

Bidders shall submit: (1) The per Residential Unit per month bid price for Collection Contractor to provide collection, transportation and delivery for disposal and processing of Solid Waste, Recyclable Material, and Yard Waste; and (2) The additional costs of the Collection Contractor providing each Residential Unit with Solid Waste and Recyclable Materials collection containers and the Collection Contractor retains ownership of collection containers at the end of the five (5) year term; and

The additional costs of the Collection Contractor providing each Residential Unit with Solid Waste and Recyclable Materials Collection containers and the City/Township owns the collection containers at the end of the five year term. If Option 3 is selected, the Collection Containers shall be unbranded except that they shall be clearly identified as either a Solid Waste container or a container for Recyclable Materials.

***ALTERNATE BID – UNLIMITED AT THE CURB**

For this Bid Option:

- Each residential household will have two (2) carts, one (1) for recycling and one (1) for solid waste. The volume of Solid Waste placed in the Collection Container or curbside for collection by each Residential Unit shall be unlimited. Bulk items shall be collected during regular weekly collection and is NOT limited to the first or third collection weeks of the month. Residents are not required to schedule bulk pickups.
- Gahanna's collection days shall be Monday and Tuesday, Reynoldsburg's collection days shall be Thursday and Friday. In the event only Gahanna selects this bid option, the City will be split into four (4) zones with collection days being Monday through Thursday. In the event only Reynoldsburg selects this bid option, the City will be split into five (5) zones with collection days being Monday through Friday.
- All collection vehicles will be fueled by Compressed Natural Gas (CNG). These vehicles operate nearly 100% free of emissions.
- If the communities select the Contractor Supplied Container Option, the following provisions shall occur:
 - Each community will select their "standard" cart sizes for trash and recycling. These cart sizes will be distributed to each residential household.
 - Prior to distribution, Local Waste Services (LWS) will send out a postcard giving residents the option to select a cart size other than the "Standard" size selected by the Community. Any residents who do not return their postcard WILL receive the "Standard" sized carts.
 - For residents who do not submit their post cards prior to the specified deadline, LWS will allow a 90-day period to deviate from the standard cart size that was originally delivered at no additional charge. After this grace period, cart sizes may still be changed at the price listed on Exhibit G – Bid forms – Part II. Additional charges do not apply to medically required cart changes.
- The communities shall be responsible for the recycling processing fees as stated in Addendum I.
- Term shall be five (5) years commencing January 1, 2019 and ending December 31, 2023.

It is anticipated that the standard size for Recyclable Materials collection containers will be 64 gallons. However, the Participating Communities will allow Residential Units to choose a 96 gallon Recyclable Materials Collection Container.

Bidders shall submit per Residential Unit per month bid price for collection, transportation and delivery of Solid Waste, Recyclable Materials, and Yard Waste as follows: (1) Collection Contractor provides collection of Solid Waste, Recyclable Material, and Yard Waste; (2) Collection Contractor provides each Residential Unit with Solid Waste and Recyclable Materials collection containers; and (3) Collection Contractor provides each Residential Unit with Solid Waste and Recyclable Materials collection containers and the City owns the collection containers at the end of the five year term.

The “COLLECTION BID AND USE OF COLLECTION CONTAINERS” is described as follows: **The City or Collection Contractor provides each Residential Unit with two wheeled collection containers at the prices submitted above; one black, brown, or gray for Solid Waste and one blue for Recyclable Materials.** The Collection Contractor is requested to give a discounted price for any Residential Unit that requests a 48 or 64 gallon Solid Waste collection container instead of a 96 gallon Solid Waste collection container, based upon lower disposal costs.



It is anticipated that the standard size for Recyclable Materials collection containers will be 64 gallons. However, the Participating Communities will allow Residential Units to choose a 96 gallon Recyclable Materials Collection Container.

Bidders shall submit per Residential Unit per month bid price for collection, transportation and delivery of Solid Waste, Recyclable Materials, and Yard Waste as follows: (1) Collection Contractor provides collection of Solid Waste, Recyclable Material, and Yard Waste; (2) Collection Contractor provides each Residential Unit with Solid Waste and Recyclable Materials collection containers; and (3) Collection Contractor provides each Residential Unit with Solid Waste and Recyclable Materials collection containers and the City owns the collection containers at the end of the five year term.

***ALTERNATE BID – LIMITED AT THE CURB**

CART CONTENTS ONLY

For this Bid Option:

- Each residential household will have two (2) carts, one (1) for recycling and one (1) for solid waste. The volume of Solid Waste placed in the Collection Container or curbside for collection by each Residential Unit shall be limited to only what fits in the carts. Any material that is not placed inside the cart will be left at the curb and a picture of the violation will be posted to the customer's account after the 90-day grace period. During this grace period, any violators will be tagged to contact our office but the additional material will be collected.
- Bulk items will be collected weekly on the collection day when each item is scheduled 24 hours in advance by contacting Local Waste Services, or submitting a request online at localwasteservices.com. Extra trash or recycling that does not fit in the provided containers will not be collected as bulk items.
- Gahanna's collection days shall be Monday and Tuesday, Reynoldsburg's collection days shall be Thursday and Friday. In the event only Gahanna selects this bid option, the City will be split into four (4) zones with collection days being Monday through Thursday. In the event only Reynoldsburg selects this bid option, the City will be split into five (5) zones with collection days being Monday through Friday.
- All collection vehicles will be fueled by Compressed Natural Gas (CNG). These vehicles operate nearly 100% free of emissions.
- If the communities select the Contractor Supplied Container Option, the following provisions shall occur:
 - Each community will select their "standard" cart sizes for trash and recycling. These cart sizes will be distributed to each residential household.
 - Prior to distribution, Local Waste Services (LWS) will send out a postcard giving residents the option to select a cart size other than the "Standard" size selected by the Community. Any residents who do not return their postcard WILL receive the "Standard" sized carts.
 - For residents who do not submit their post cards prior to the specified deadline, LWS will allow a 90-day period to deviate from the standard cart size that was originally delivered at no additional charge.
