## A. CALL TO ORDER - Invocation, Pledge of Allegiance, Roll Call

Gahanna City Council met in Regular Session on Monday, March 7, 2011, at Gahanna City Hall, in Council Chambers, 200 South Hamilton Road. President of Council David L. Samuel called the meeting to order at 7:00 p.m. Invocation was given by Vice President Brian Larick followed by the Pledge of Allegiance led by Boy Scout Troop 317. Agenda for this meeting was published on March 4, 2011.

#### C. HEARING OF VISITORS.

Scott Mounts, School Board Representative said it has been a rather melancholy day for the schools as Superintendent Mark White announced reduction in forces for school employees; we are going through a budget reduction process that seems to change every day; trying to reduce the budget by about \$7 million; \$4.5 million from teaching staff; will reduce our administrative payroll by about \$1.2 million; our administrators took a cut in pay in the form of furlough days as well as salary and step freezes; are looking at about a \$342,000 reduction in our classified staff; some miscellaneous items; if the levy on the May ballot does not pass we would eliminate high school busing as we do not have to offer it to high school students; would continue for elementary and middle school as we are required to; if levy would pass would reinstate high school busing; also if the levy does not pass will initiate pay to participate fees for athletics and some other extra curricular activities; that is what is going on. Thank you.

Nick Hogan, 1040 Venetian Way, said I would like to share a presentation with Council and then have a list of questions that need to be answered; here to discuss protection of public property; have verified with the Finance Department that the City paid 100% of construction costs of the paved brick area and is to receive \$2.00 per foot on all space that was 100% paid for by the developer; am passing out drawing with 4 areas marked on it; when on Council asked if all of this area with paver block is public property; were told it was; what happened to me, I was teaching a class in the convention center and I came outside at break and saw a little girl with her mom and dad eating an ice cream cone in the area marked no. 3; ice cream was dripping so I suggested they move over in the shade at a table and the dad said they were over there and sat down but the owner of the business came out and said this property is exclusively mine to use and you cannot sit here with your ice cream cone unless you purchase something from my business; they were taxpayers of Gahanna who paid for this piece of property but were told they cannot sit there; area no. 2, on numerous occasions has been fenced off; the only way to get into the public area was to go through Buck Mulligan's; then last summer there was a bar there; supposed to be public space; also Mezzo has walled off and fenced in area around the restaurant exclusively for their use; taxpayers of Gahanna paid for this property and it should be open to the public; have picture from your website that lists everything that is supposed to be public; did verify through Finance Department that Gahanna paid 100% of the cost for the paved area. Hogan submitted a list of questions he would like answered, and Mayor Stinchcomb said she would respond to them.

Patrick Moran, 511 Howland Drive, said I am a Star Scout from Troop 317 and currently the patrol leader; we are here to observe your meeting and are working on a merit badge; are from St. Matthews.
