#### MORPC Grant of the Month:

- The U.S. Department of Agriculture (USDA) is awarding \$50,000-\$1 million in Broadband Technical Assistance Grants for eligible entities looking to promote broadband expansion into a rural community. No local match is required.
- Applications are due August 20, 2024. More information here.

## Other Funding Opportunities:

- Good Jobs Challenge
  - o Department: Department of Commerce Economic Development Administration
  - o Available funding: \$25 million available, awards will range from \$1 million to \$8 million
  - o Application deadline: September 27, 2024
  - o Eligible Applicants: Local government, States, Institutions of higher education, Public or private non-profits, Government organizations engaged in economic or infrastructure development
  - o Eligible Projects: Design and implementation of training programs for established or emerging sectoral partnerships, such as: Registered apprenticeship programs, Skills training programs, Pre-apprenticeship programs, Work-and-Learn models, Certificate/credentialing programs, Labor management training programs

- Clean Energy to Communities Program: Expert Match
  - o Department: Department of Energy National Renewable Energy Laboratory
  - o Available Funding: This is a technical assistance program that provides 40-60 hours of assistance over 3-4 months, based on application submission date.
  - o Application deadline: Rolling
  - o Eligible Applicants: Local government, Regional planning organizations, Community-based organizations, Nongovernmental organizations, Municiple or coop utility, Institutions of Higher Education
  - o Eligible Projects: Free, short-term, technical assistance to address near-term clean energy challenges and questions

## • Reconnecting Communities Pilot Grant Program

- o Department: Department of Transportation Office of the Secretary
- o Available Funding: \$607 million in total program funding
- o Application Deadline: September 30, 2024
- o Eligible Applicants: States, State Governments, Local Governments, Non-profits, Metropolitan Planning Organizations
- o Eligible Projects: Transportation planning activities that restore community connectivity, Public engagement, Development of community connectivity facilities

## • Recycling and Litter Prevention Grants

- o Department: Ohio Environmental Protection Agency
- o Available Funding: Awards range from \$10,000 \$300,000
- o Application Dates: October 7, 2024 December 6, 2024
- o Eligible Applicants: Ohio Schools, Counties, Heath departments, Municipal corporations, Non-profits, Park districts, Private sector businesses, Solid waste management authorities, State agencies, Townships, Villages
- o Eligible Projects: Initiate or expand recycling programs, Encourage sustainable practices, Stimulate economic growth, Support litter prevention efforts

#### **MORPC Educational Benefits:**

• MORPC has partnered with Ohio University and Otterbein University to enhance benefits for its members employees, and immediate family in some programs, by offering discounts on undergraduate and graduate programs. More information here.

#### Legislative Update:

- State lawmakers in both houses have passed a \$6.2 billion Capital Budget, HB 2, which includes appropriating over \$700 million in One-Time Strategic Community Investment Funds (OTSCIF). Over \$140 million in OTSCIF funding was appropriated for Central Ohio Projects.
- The Bill reappropriates nearly \$595 million for the Ohio Public Works Commission. It also imposes a 10% cap on annual funds that district public works integrating committees can give to political subdivisions seeking interest-free or low-interest loans under the State Capital Improvement Program.
- After passing HB 2 at the end of June, the Ohio Legislature is now in recess and won't be back in session until after the November election.

#### ASPYR RECEIVES \$4 MILLION ABA GRANT TO EXPAND REGISTERED APPRENTICESHIPS IN CENTRAL OHIO

Aspyr (formerly known as the Workforce Development Board of Central Ohio) has been awarded a \$4 million grant from the U.S. Department of Labor to establish and grow registered apprenticeships in Central Ohio. This grant will allow Aspyr and South Central Ohio Workforce Partnership (SCOWP) to expand high-quality training and employment opportunities to individuals in the region including Franklin, Fairfield, Ross, Pickaway, Hocking, and Vinton Counties. The grant, provided through Apprenticeship Building America (ABA), will enable Aspyr and SCOWP to develop and implement registered apprenticeship programs in various in-demand industries, such as healthcare, manufacturing, and education. These programs will provide individuals with hands-on training and valuable skills, leading to well-paying jobs and career advancement opportunities.

Aspyr and SCOWP are excited to begin the implementation of these registered apprenticeship programs and look forward to the positive impact they will have on the community.
