CALL TO ORDER

Chair Larick called the meeting to order at 9:08 p.m.

Present 3 - Brian D. Larick, Karen J. Angelou, and Stephen A. Renner

ITEMS FROM THE DIRECTOR OF DEVELOPMENT

1. 2016 Contract with the Gahanna Community Improvement Corporation

Jones said there is no recommended funding changes; same as last year; two minor changes in subsection 2E, it was moved to its own section to show have satisfied obligations; also removed item number F in Section 3; have 95% leased right now; removed the reference to \$75,000 in paragraph three; was originally allocated in previous budgets; those funds are not there and they do not want to refer to that; Larick said they have an ongoing management agreement; Jones said yes and they have been a great group to work with; Angelou asked if 181 Granville would continue to be entreprenuerual; Jones said it does not state it will be torn down; said there are leases going through July; have had discussions of long term maintenance of the property; said the CIC has been spending those dollars; at this time the City will receieve the property back in 2017; will hope to use the property to push a road through at some future date; Angelou said we have current roads that need repaired; trying to find why we would not keep it open to continue to make money; said there have been ongoing tenants there; asked when it will be paid for; Jones said in 2017; believe last year the property made \$2,000 and that is excluding some expenses we have incurred; Angelou said Dr. Low**** has been in there for a long period of time; Jones said the roof has been a problem for him for quite some time; Larick said the concern is the limited revenue with offset of obligations of it having leases; when that roof fails to the point that we have to do the capital investment, there is no return on the leases; have been patching the HVAC and getting it to the point that it is functional; said the building cannot cover the

captial improvement costs; CIC has looked at the best revenue and risks of the City; Angelou said did not support purchasing the building in the first place; said does not believe it will be well receieved; Jones said believes having better access to Friendship Park will be well receieved; Euton said there were plans to have a recreation center there in the past; Larick said it comes back to the ongoing loss of dollars to the CIC and to the City; Angelou asked how much we have made from the selling of fiber; Jones said we have ten with eleven being signed up right now; said in 2014 there were 5 and 3 so far in 2015; Angelou asked if the CIC website/brand has been redone; Jones said it has and the website has been well receieved by existing and new businesses.

Jones said there are two minor changes; one is recognized in the beginning asking that the Director of Parks and Director of Development always be present at the meetings.
