A. CALL TO ORDER - Invocation, Pledge of Allegiance, Roll Call

Angelou noted that there is a motion resolution on the consent agenda this evening for approval of the budget. Note that the figure on the changes page for utilities is a reduction of \$5,000 and should be in brackets to reflect that.

C. HEARING OF VISITORS

Richard Peck, 122 Oklahoma Avenue, addressed Council concerning the Oklahoma Avenue Street Improvement project; presented pictures to Council of what the street looked like Saturday morning and then what it looked like after crews came in and took out four 60 year old trees from his yard; was hoping something could be done to stop this; have been working with the administration; this project is not neighborhood driven; residents did not ask for this improvement; felt with the adoption of the Creekside Trailway Loop Study access for pedestrians to Friendship Park was being provided; at the very least could have done sidewalks on one side of the street; can't replace these trees but something could have and should have been done to accommodate this special area.

Patricia Peck, 122 Oklahoma Avenue, stated her concerns were related but slightly different; wish to address the issue of utility poles on Clark and Oklahoma; with the removal of trees utility poles are what you see when you look out the windows of my residence; sidewalks that are being installed are going to be narrow and the utility poles will be in the sidewalks; as you know from walking on Granville and Mill Street that is not always navigable; with our sidewalks being narrower don't see how it can work;

suggest that we consider moving the poles to the rear of the properties; believe there are additional poles already there; spoke with power company and cost is only \$1,000 to \$2,000 per residence; don't know what can be done but it would be an option that should be considered.

Angelou noted that the poles were not moved on Mill Street because several business owners did not want to do it; utility companies had stated everyone had to do it or it couldn't be done; cost is significant; believe the cost quoted to you is the cost to the resident not what the actual cost is for moving the lines but the cost to restore service to each residence.

Payne assigned these items to Committee of the Whole for July 24.

James-Arnold thanked Council for moving this item to the Regular Agenda; spent much time on this and this week have spoken with Chief and Deputy Chief; thank them for all the information provided; O'Brien has talked about the soft costs; agree with him on that; but we have recently upgraded many of our laws allowing us to move forward with enforcement of PUCO regulations; can stop for more than weight now; if we enforce for other issues, trucks will begin to stop cutting through because they know we enforce; all got the Chief's memo on the costs; the scales will be somewhere around \$52,000 to purchase; with all costs including officers we're at approximately \$175,000; when we weigh we need to call in another officer so we're committing the time of two officers; just don't see how we will recoup costs; in talking with other cities finding that the officer is being dedicated to this for 40 hours a week and revenue generated does not cover the cost; we need to focus on our other problems like speed; we are under attack in our neighborhoods by speeders; can't support.

O'Brien stated he appreciated the memo from Chief Murphy; did ride with Officer Apple when we started talking about this; stopped a truck that was 40,000 lbs overloaded and

had illegal connections; we need to stop these trucks in our city; if they had been travelling on a curve it would have easily tipped and caused us bigger problems; we can't begin to know the costs involved to our street improvement program.

Angelou noted truck after truck coming down Clotts Road; has to be doing damage to that street; agree with O'Brien; deterrent is there to make truckers choose other routes; feel this will be well worth the money.

Hogan stated he agreed with James-Arnold; can stop for other issues; officers are trained to spot unsafe trucks; 9 times out of 10 we're getting trucks on other violations and not on weight; not sure trucks would stop coming through; they may just avoid some of the main streets.

Payne stated she had also ridden with Officer Apple; found out that roads that were wavy in the middle are caused by overweight trucks; are times we can't do anything if we don't weigh.

McGregor stated he had not been a proponent of specialization; fought the bike patrols in the beginning; fought the dog; now have a horse patrol; am finding out that specialization does work; Frank Stewart who works with the dog is one of our most productive officers; am finding that an officer who is working in a specialized area is more interested and more involved and therefore more productive; have more than doubled the department in the 17 years I've been here; no new officers next year but we are doing more work; covering the city better and more efficiently; and have productive officers.

Angelou noted that no new officers are in next year's budget is because they have been hired early; are ahead of the study done several years ago in terms of hiring new officers; our bottom line is still the health, safety and welfare of our citizens; 10 years ago I would not have agreed that this specialization was needed; have found that the bike patrols, the dog, and the part time officers are all things that work well for us.

O'Brien noted that since we went to specialization, Gahanna has seen a decrease in crime with all other suburbs having an increase. McGregor noted it was not quite true to say there will be no increase in officers next year; with part time working as Court Bailiff we have freed up an officer to be on the street; with the hiring of a Communications Director yet this year we will be redeploying a sergeant back onto the street.
