#### **A. CALL MEETING TO ORDER - Roll Call.**

#### **B. Director of Human Resources - ORD-0030-2016 DISCUSSION**

Director of Human Resources Abby Cochran said she is respectfully requesting authorization from Council to offer a candidate for the position of GIS Administrator a rate of pay above the Midpoint/Market of their range; the City has been actively recruiting for the GIS Administrator position since it became vacant in January 2015; this position is important to City operations specifically in the areas of Public Safety, Development, Public Service, and Parks & Recreation; we also provide GIS hosting services for a neighboring municipality which brings \$18,000 of revenue annually; some of the duties have been completed through internal resources and contracted services over the past year; however, said cannot realistically continue to operate without this position; due to the length of time that this position has been vacant; she requested a waiver and an emergency for this action item.
