# ACTION ITEM #4: CREEKSIDE FLOOD IMPACT MITIGATION, PHASE 1 – CONTRACT AWARD

The Department of Public Service and Engineering is requesting an ordinance authorizing the Mayor to enter into contract with Fishbeck for professional services associated with Phase 1 of the Creekside Flood Impact Mitigation project.

The focus of this project is to improve flood protection measures at the Creekside Development to meet National Flood Insurance Program (NFIP) standards. Phase 1 of the contract with Fishbeck will include investigation and planning efforts to guide the design and construction of potential improvements to the below-grade structure and plaza.

DLZ Ohio, Inc. evaluated the Creekside Development's flood protection measures in 2020. They identified several deficiencies that need to be addressed in order for the facility to meet NFIP requirements. This contract with Fishbeck builds from that evaluation and begins exploring the feasibility and effectiveness of floodproofing options.

Fishbeck is the lead consultant of a team that was selected following Gahanna's procedure for securing professional services. Fishbeck responded to a Request for Proposals that was issued by the City on July 26, 2021. After careful review, Gahanna's selection committee found Fishbeck's proposal to be best suited for the project due to their team's extensive experience with flood mitigation of commercial buildings and parking garages through Michigan.
