ACTION ITEMS FROM THE CHIEF OF POLICE

ACTION ITEM # 1 - Franklin County Natural Hazards Mitigation Plan - 2018

In 2018, Franklin County's Office of Emergency Management and Homeland Security completed revisions to the Natural Hazards Mitigation Plan after over a year of research and gathering input from representatives of various local government agencies as well as other stakeholder organizations. The purpose of the plan is to address Franklin County's history of experiencing damage from flooding, tornadoes, severe summer weather, severe winter weather and other hazards resulting in property loss, loss of life, economic hardship and threats to public health and safety. The plan was last updated through a similar process in 2012 with Council taking legislative action in support.

In 2019, the plan was published detailing recommendations focused on mitigating the impact of natural hazards on the residents and property within Franklin County. Locally, the plan was forwarded to the directors of Parks & Recreation and Public Service for review. Now that the plan is formalized, Franklin County's Office of Emergency Management and Homeland Security has requested that each local unit of government formally recognize the plan through legislative action as a condition of eligibility to receive federal mitigation funds from the Federal Emergency Management Agency (FEMA) should a qualifying natural hazard event impact Gahanna.

The Division of Police respectfully requests passage of a resolution in support (see Attachment A) of the Franklin County Natural Hazards Mitigation Plan (see Attachment B).
