3. The rates in this Pricing Schedule are the applicable Tariff or Guidebook rates currently in effect. Billing for the Service will begin when the Term begins (as set forth below). The rates charged will be those listed in this Pricing Schedule (or Service Guide if not listed in this Pricing Schedule) and may change, but during the Term in no case exceed the rates in effect at the time Service is installed. The rates in this Pricing Schedule are exclusive of, and Customer will pay, all current or future taxes, regulatory surcharges, recovery fees, shipping charges, and other similar charges specified or allowed by any governmental entity relating to the sale, use or provision of the Services.

4. The Effective Date of this Pricing Schedule is the later of the signature dates above. The Term begins ("Term Start Date") (1) if this Pricing Schedule is only for "New Install" as checked above, on the date when the Service is installed and available for use by Customer pursuant to this Pricing Schedule, or (2) if this Pricing Schedule is for "Renewal" as checked above, on the Effective Date of this Pricing Schedule*, and the Pricing Schedule terminates automatically at the end of the Term based on the number of months selected above. At the end of the Term, the Service will automatically be provided to Customer under the terms and conditions of the applicable Tariff or Guidebook and BSA, on a month-to-month basis at the then-current month-to-month Tariff or Guidebook rates unless and until execution of a then available term plan for the Service or until AT&T or Customer cancels the Service on 30-day prior written notice.

5. If Customer cancels this Pricing Schedule prior to the Term Start Date, Customer will reimburse AT&T for time and materials incurred prior to the effective date of termination, plus any third-party charges resulting from the termination.

6. If Customer terminates the Service, in whole or in part or AT&T terminates for Customer's default, on or after the Term

Start Date but prior to the expiration of the Term (except as otherwise permitted in this Pricing Schedule), Customer will be liable for the early termination charge equal to 50 percent (50%) of the recurring monthly charges for the terminated Service multiplied by the number of months remaining in the Term at the point of termination plus any unpaid Special Construction or non-recurring charges (excluding any waived charges). For Services provided in Ohio, inclusion of termination liability in this Agreement does not constitute a determination by the Public Utilities Commission of Ohio that the termination liability is approved or sanctioned. Customer is free to pursue its legal remedies should a dispute arise.

7. Customer may upgrade the DS1 Service to a higher speed service provided by the same AT&T Service Provider as designated above (the "Upgraded Service") without incurring early termination charges; provided that the Upgraded Service is under a term plan that is equal to or greater in length than the number of months remaining in the term plan ordered herein and is installed between the same locations as the applicable DS1 Service. Non-recurring charges will apply to the Upgraded Service.
8. During the Term, Customer may move one Channel Termination of a circuit to another location in the same LATA and keep the Term in force, provided no lapse in service occurs. Moves to a different Serving Wire Center may result in a change in the monthly rates. Non-recurring charges, as appropriate, apply. If Customer moves both ends of the service concurrently, Customer will be liable for early termination charges.
9. Customer acknowledges and certifies that the total interstate traffic (including Internet traffic) on the Service constitutes ten percent (10%) or less of the total traffic on the circuit(s). This provision is not applicable when the Service is used solely for the transport portion of AT&T local access switched voice services.

* For Connecticut, if this Pricing Schedule is for "Renewal" as checked above, the Term begins on the later of the Effective Date of this Pricing Schedule or on the anniversary date of the date that the Service was first provided to Customer.
