Charter Review Commission Overview Under Article 22 of Gahanna's Charter

The City of Gahanna Charter Review Commission (CRC) is a commission outlined in the Gahanna City Charter.

The Commission reviews the City's Charter and recommends to Council such alterations, revisions, and amendments, if any, to the Charter, as in its judgment are desirable.

The Commission will determine its own processes and procedures and will be guided and supported by the City Attorney and City Clerk. The CRC has *full latitude* in its recommendations as long as they do not conflict with state or federal law.

These recommendations are due to the Gahanna City Council in a formal report by July 1st of the year in which the commission meets.

These recommendations are individually submitted to the voters of the city at the next general election and become law if a majority of electors vote in the affirmative.

<u>Under Article 22 of Gahanna's Charter,</u> <u>the Charter Review Commission:</u>

- Is a commission of seven (7)
 qualified electors, holding no other
 office or appointment in the city.
 - Four (4) of the members are appointed by the council, and three (3) are appointed by the mayor.
 - The City Attorney sits on the commission ex officio.
 - The City Clerk sits on the commission ex officio.
 - Must meet every 5 years. Taking place during years ending in 1 and 6.
- Review the municipal charter in meetings open to the public.
- No later than July 1st of the same year, make their recommendations to the Gahanna City Council.

What's a Charter?

In Ohio, a city charter is a legal document that allows a municipality to operate under "home rule". A Home Rule Charter gives a municipality greater local control and flexibility in how they are governed than the state statutory form.

Adopted by local voters, a charter serves as a city's constitution. It outlines the structure of local government, the roles of elected officials, and the procedures for passing ordinances and managing services.

Gahanna CRC Structure

The charter of the city of Gahanna allows significant leeway in how the commission organizes itself and conducts its business.

The City Attorney and Clerk of Council (or Deputy Clerk) sit on the commission as "Ex Officio" Members and do not hold voting rights. The City Attorney advises the commission as it pertains to legal matters, while the Clerk records minutes, conducts official CRC processes, and facilitates external communications. Both are also excellent sources of institutional knowledge for the commission to utilize.

A Chair of the Commission is required under section 22.04 of the Gahanna Charter for the certification of a new charter. By practice, a Vice Chair of the Commission is also elected. Both the Chair and Vice Chair are selected through a vote by the seven commission members.

Outside of the official duties of the CRC Chair, the Chair and Vice Chair have historically taken to informally leading the commission. This includes but is not limited to: leading deliberations, shepherding meetings, ensuring all members have a voice, conducting consensus-building practices/activities, and tracking CRC progress.

Additionally, the CRC customarily gives a presentation on their recommendations to the Gahanna City Council following the submission of their official report. Any member of the commission may conduct the presentation, but this has historically been conducted by the Chair and Vice Chair of the commission.

Key Deliverables of the CRC

1. CRC Recommendation Report to City Council

The Charter Review Commission Report is the core deliverable of the commission and is required by the City Charter to be submitted to Council by July 1st.

This report is a compiled list of all the proposed amendments the CRC is recommending to be voted on.

Core Components:

- A preamble describing the general process and experience of the CRC, and whether any overall themes or intentions exist in the recommendations made.
- A list of each proposed amendment with a summary of the change or new article proposed.
- A signature page from the commissioners.

2. CRC Report Presentation to City Council

The CRC report presentation is the opportunity for the CRC to formally submit and explain their proposed amendments to the City Council and the public. This presentation has typically been led by the Chair and Vice Chair of the commission during a Committee of the Whole meeting after submission of the report. However, any member of the commission may lead or be a part of the presentation.

Afterwards, the Council adopts the recommendations via resolution to be submitted to the electors of Gahanna at the next general election.

3. Certification of the new charter

After the election is held in which the proposed amendments were voted on, the Clerk of Council will reassemble the CRC for a final meeting. In this meeting, the Chair of the Commission must sign the final updated charter for the City of Gahanna. After this certification process is complete, the work of the current CRC is concluded.

Hold Public Input Hearings

All CRC meetings will be open to the public, but the CRC has historically held 1-3 public input meetings dedicated to hearing from the community


Commission Activities are methods of gaining understanding, building consensus, and/or whittling down decisions for the commission.

GAHANNA CITY HISTORY & GOVERNMENT

History



Gahanna was founded along the Big Walnut Creek in 1849 by John Clark. Clark named his property the Gahanna Plantation, from which the City of Gahanna derives its name. The name "Gahanna" translates from a Native American word meaning "three creeks joining into one" and is the former name of the Big Walnut Creek. The City of Gahanna's Official Seal refers to this confluence of three creeks with the inscription, "Three In One."

Gahanna maintained a considerable rivalry with the town of Bridgeport, which was located directly across Granville Street from Gahanna and also along the banks of the Big Walnut Creek. Bridgeport was founded in 1853 by Jesse Baughman, a former Franklin County Commissioner. The two towns eventually put aside their differences and merged into one. They adopted the name Gahanna and incorporated into a Village in 1881. Today, Gahanna is

a 12.6 square mile home-rule municipality located within Franklin County in central Ohio.

City Government

The City is governed by the laws of Ohio and the City Charter, its constitution, which can only be amended by a majority of the City's voters.

The City's elected officials are the Mayor, the City Attorney, and the seven members of the City Council. The City Charter provides the constitutional framework within which city government operates. The City's codified ordinances contain the laws of the City.

City Council

All legislative powers of the City are vested in the City Council. City Council members exercise their duties by adopting legislation in the form of ordinances or resolutions. Four members are elected from geographic wards and three are elected at-large by all voters of the City. All members serve four-year terms. The City Council is responsible for passing an annual appropriations ordinance and authorizing the Mayor to sign contracts and agreements as applicable. City Council determines its own rules of procedure, and each year elects from its membership a President and Vice-President to preside over its meetings. Council meetings and their proceedings are open to the public.

Gahanna's Mayor

The City has a strong Mayor-Council form of government. The Mayor is popularly elected by the citizens of Gahanna, serves a four-year term, and serves as the Chief Executive Officer of the City. As the City's chief administrator and official representative, the Mayor is responsible for the general management of the City and for ensuring that all laws and ordinances are enforced. The Mayor appoints professional directors to the City's departments, who administer the day-to-day operations of the City.


City Attorney

The City Attorney is an elected position that provides advice and legal representation to the City, elected and appointed officials, and employees of the City in their official capacities. The City Attorney prosecutes or defends all suits for and on behalf of the City and ensures that the interests of residents are protected. The City Attorney serves also as legal counsel for the City's various boards and Commissions.

CITY ORGANIZATIONAL STRUCTURE

The City's organizational structure is designed to support quality services to the citizens of the Gahanna community. The day-to-day operations of the City are managed by the Mayor and appointed department directors. The City is staffed by a mix of full-time, part-time, and seasonal employees whose compensation and benefits are authorized through three bargaining-unit contracts and multiple separate annual salary and benefit ordinances.

Boards & Commissions

Community Reinvestment Area Housing Council

Meets as needed to conduct annual property inspections, act as an appellate board for tax abatement disputes, and recommend approval of the annual tax abatement report filed with the State.

Fair Housing Board

Meets as needed to hear complaints on alleged housing discrimination in accordance with Chapters 790, 791, and 792 of the Codified Ordinance of the City of Gahanna.

Property Appeals Board

Meets as needed to hear and decide appeals when it is alleged that there is an error in any requirement, decision, or determination made by the Designated City Official in the enforcement or administration of Chapters 780, 1308, 903 and 521.06.

Charter Review Commission

Convenes every five years to review the municipal charter and recommends amendments, if any, to Council.

Landscape Board

Meets as needed to study,
investigate, counsel, and develop
and/or update and administer a
written plan for the care,
preservation, pruning, planting,
replanting, removal or disposition of
trees and shrubs in parks, along
streets and in other public areas.

Planning Commission

Meets twice per month to evaluate the planning and design, location, removal, relocation, and alteration of new or existing structures, approve plats, and advise Council on issues concerning future physical development of the city.

Board of Zoning & Building Appeals

Meets as needed to hear and decide appeals pertaining to zoning, building, and landscaping in the City.

Civil Service Commission

Meets as needed to hear and decide appeals/grievances from administrative determinations pursuant to the provisions of the Civil Service Rules and Regulations.

Local Board of Tax Review

Meets as needed to hear appeals from taxpayers regarding decisions made by the City's tax administrator (RITA) and the Director of Finance.

Parks & Recreation Board

Meets monthly to make recommendations to the Mayor on equipping, operating, directing, and maintaining all the recreational facilities, park facilities, and City recreational programs.

Records Commission

Meets at least twice per year and as needed to establish rules, regulations, and procedures for the retention and disposal of all City records and archives.




Your Real Estate Tax Dollar At Work
