ACTION ITEMS

ACTION ITEM #1: AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO AWARD AND THE MAYOR TO ENTER INTO CONTRACT WITH COMPLETE GENERAL CONSTRUCTION FOR STREETLIGHT AND TRAFFIC INFRASTRUCTURE MAINTENANCE.

The Department of Public Service manages nearly 1,900 streetlights and over 40 signalized intersections located throughout the City. This infrastructure requires periodic maintenance to remain in good working order, which is performed by an outside vendor. Maintenance work includes the components for overhead and decorative streetlights, as well as traffic control components located at intersections. The contractor is also responsible for upgrading fixtures to LEDs and replacing pole and other components when they are damaged. The current contract expires December 31, 2023.

On September 29, 2023, bids for streetlight and traffic infrastructure maintenance were opened and reviewed. Three (3) bids were received, one (1) of which was deemed to be non-responsive due to failure to provide required information. The lowest responsive and best bidder is Complete General Construction. The initial term of the contract is for three (3) years, commencing January 1, 2024 and ending December 31, 2026. The contract also includes a provision for two (2) separate consecutive renewals of one (1) year each upon written mutual agreement of both parties (January 1, 2027 – December 31, 2027, and January 1, 2028 – December 31, 2028, respectively).

The Administration is respectfully requesting an Ordinance authorizing the Director of Public Service to award, and the Mayor to enter into, a contract with Complete General Construction for streetlight and traffic infrastructure maintenance.
