There is a new Central-Ohio resource hub on the website; will have the MORPC summer interns program again; Gahanna has benefited from the work of those interns; will have a new series for Celebrate One, to reduce infant mortality; a Resolution was adopted for population estimates for membership fees; MORPC is going through the Clean Ohio application process for Franklin County; the Metropolitan Planning Organization covered recent grant applications; waiting to hear back about the Build Back Better grant for the region; had a presentation on Link Us, the mobility initiative.
