TO AUTHORIZE THE MAYOR TO ENTER INTO AGREEMENT WITH FRANKLIN SOIL AND WATER CONSERVATION DISTRICT FOR EROSION AND SEDIMENTATION CONTROL AND INSPECTION FOR DEVELOPMENT PROJECTS FOR 2015.

WHEREAS, under the City's National Pollutant Discharge Elimination System (NPDES) Gahanna is required to meet certain Ohio EPA requirements in order to be compliant with the program; and

WHEREAS, the purpose of this agreement is to provide environmental education and public participation relating to storm water pollution and to provide assistance to the City on illicit discharge detection and elimination; and

WHEREAS, Gahanna has been working with Franklin Soil and Water Conservation District (FSWCD) on many aspects in our Program and wishes to enter into agreement with them to perform the tasks related to storm water conservation and illicit discharge detection and elimination; and


WHEREAS, the Director of Public Service has recommended we proceed with FSWCD;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:


Section 1. To authorize the Mayor to enter into Agreement with FRANKLIN SOIL AND WATER CONSERVATION DISTRICT to perform tasks as outlined in Agreement attached as EXHIBIT A, and made a part herein.

Section 2. That funding in the amount of TWELVE THOUSAND ONE HUNDRED TWENTY-FIVE DOLLARS (\$12,125) was set aside in the 2015 Appropriations to Account No. 631.350.5470, Stormwater, Water, Regulatory Requirements, to cover the herein costs.


Section 3. That this ordinance shall be in full force and effect after passage by this Council and 30 days after date of signature approval by the Mayor.
