<u>ACTION ITEM #1: MUNICIPAL LANDSCAPE MAINTENANCE – AWARD CONTRACT & SUPPLEMENTAL</u>

In March this year, AmeriScapes, who was the vendor for the City's municipal landscape maintenance contract, submitted their notice of contract termination, to be effective within thirty (30) days. On March 21, 2022, Council granted permission to the Administration to bid the Municipal Landscape Contract.

On April 15, 2022, bids were opened and reviewed. The lowest responsive and responsible bidder is Brightview Landscapes. The bid price is \$159,136 per year. The term of the contract is for the remainder of 2022 and two (2) full calendar years thereafter, ending December 31, 2024. The contract also includes two (2) separate, consecutive renewals of one (1) year each upon written mutual agreement of both parties (January 1, 2025 – December 31, 2025, and January 1, 2026 – December 31, 2026, respectively).

It should be noted that every bid that was received for the new contract, including the bid from Brightview Landsccapes, was higher than the City's previous contract with AmeriScapes. The increase in pricing can be attributed to a handful of factors, including labor shortage, inflation, and higher fuel prices. In addition, AmeriScapes historically has bid significantly lower than all other municipal landscaping companies. During previous bid processes, landscape companies specifically noted that they were not interested in bidding as they were not able to meet or beat AmeriScapes' pricing.

The Administration respectfully requests legislation authorizing the Mayor and the Director of Public Service & Engineering to enter into contract with Brightview Landscapes per the above-outlined terms. Because 2022 appropriations were based on the costs of the previous contract



that was in place with AmeriScapes, the Department of Public Service & Engineering is requesting a supplemental appropriation in the amount of \$75,000 to fund the remainder of the contract costs, including a contingency for any unforeseen expense.

Since the landscaping season has already begun, the Administration is requesting a Waiver and Emergency to begin services as soon as possible. While City crews have been doing as much as they can to keep up with mowing needs, the operations are not sustainable in the long-term and are impacting the Department's ability to work on other projects.
