AN ORDINANCE TO AMEND GAHANNA CODE CHAPTER 903 REGARDING SIDEWALK CONSTRUCTION

WHEREAS, Gahanna Code Section 903.04 currently requires a Sidewalk Permit and fee for construction of sidewalk within the public right-of-way; and,

WHEREAS, this fee collected for the Sidewalk Permit is used to pay for inspection; and,

WHEREAS, a Right-of-Way Construction Permit is also required for construction of sidewalk within the right-of-way; and,

WHEREAS, to eliminate redundancy and improve the efficiency for applicants to obtain a necessary permit to perform sidewalk construction within the right-of-way, the administration proposes that the current Code be amended to remove the requirement for a Sidewalk Permit and changing the permit fee to an inspection fee; and,

WHEREAS, the sidewalk inspection fee would be collected as part of the Right-of-Way Construction Permit process.

NOW, THEREFORE, BE IT ORDAINED, BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

Section 1. That Code Chapter 903 for Sidewalk Construction is hereby amended and adopted in EXHIBIT A attached hereto and made a part herein.

Section 2. That this Ordinance shall be in full force and effect after passage by this Council and 30 days after the date of signature of approval by the Mayor.

CHAPTER 903 Sidewalk Construction¹

Sections:

903.01 PLANS AND SPECIFICATIONS.

All sidewalks constructed within public right-of-way in the City shall be made and constructed in accordance with the latest edition of the City of Columbus Standard Construction Drawings for sidewalk and the Public Right-of-Way Accessibility Guidelines (PROWAG), current edition as proposed or adopted. Construction of new sidewalk shall be made according to the requirements of the City of Columbus Construction and Materials Specifications in force at the time of construction (as determined applicable by the Inspector), a copy of which is on file in the City Engineer's Office. Repairs to existing sidewalk shall be approved by the Director or designee, in accordance with codified ordinance Chapter 931.

903.03 WIDTH OF SIDEWALKS.

Sidewalks are to be four feet in width in residential districts. In all other districts, sidewalk widths are to be governed by the City Engineer.

903.04 PERMIT INSPECTION FEE.

The fee for a-sidewalk permit_inspection shall be in accordance with the Building and ZoningDepartment Fee Schedule.

903.05 GUARANTEE OF BUILDER, OWNER.

Sidewalks must be guaranteed by the builder or owner for a period of one year for construction and material.

903.99 PENALTY.

Whoever constructs a sidewalk in the City without having first obtained a permit therefor, shall be fined double the permit fees as outlined in the Building and Zoning Fee Schedule.
