I spoke with our Finance Department and explained the situation. If you could, please confirm as to the below:

In order to complete the filing for the Speed Way Towing appeal by the deadline, the check for \$500 was accepted by the Clerk. The check had inadvertently been pre-printed using an incorrect BZBA appeal hearing fee amount and a replacement check was not available at the time of filing. Therefore, a refund is requested on behalf of the client in the amount of the overpayment of \$300 (reference check #0239).
