TO AUTHORIZE THE MAYOR TO ENTER INTO STEELWORKERS HEALTH AND WELFARE FUND PARTICIPATION AGREEMENT; AS PROVIDED FOR IN ORD-0119-2014, WHICH AUTHORIZES THE NEGOTIATED LABOR AGREEMENT WITH THE UNITED STEEL, PAPER & FORESTRY, RUBBER, MANUFACTURING, ENERGY, ALLIED INDUSTRIAL AND SERVICE WORKERS INTERNATIONAL; TO BE EFFECTIVE JANUARY 1, 2015, THROUGH DECEMBER 31, 2015; AND TO DECLARE AN EMERGENCY.

WHEREAS, ORD-0119-2014, passed September 15, 2014, established salary and benefits for the classified employees of the City of Gahanna; and

WHEREAS, under the terms of the existing labor agreement, a cost comparison was done regarding employee group medical insurance; and

WHEREAS, the rates were just provided to the City by the Steelworkers Health and Welfare Fund; and

WHEREAS, it is critical for the orderly flow of business to allow this agreement to be entered into as soon as possible, and all for the preservation of the public peace, property, health, safety, and welfare;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to enter into "Steelworkers Health and Welfare Fund Participation Agreement" as outlined in EXHIBIT A, attached hereto and made a part herein; to be effective January 1, 2015, through December 31, 2015.

Section 2. That, for the reasons set forth in the preamble hereinabove, this Ordinance is declared emergency legislation and shall be in full force and effect after passage by this Council and upon date of signature approval by the Mayor.


