TO AUTHORIZE THE MAYOR TO SIGN THE DEALER VALUE LEASE SUPPLEMENT WITH MT BUSINESS TECHNOLOGIES, INC. WHICH WOULD ADD A MULTI-FUNCTION COPIER TO THE POLICE DEPARTMENT DISPATCH CENTER TO THE CITY'S CURRENT LEASE.

WHEREAS, the Police Department's Dispatch center currently uses a desktop printer provided by the City's Information Technology Department; and

WHEREAS, the need has arisen for the Dispatch center's printer to be upgraded to a multi-functional unit that has a higher speed and quicker output rate in order to meet the current demand and print load of the department; and

WHEREAS, it is necessary that this unit remain in the dispatch area due to the sensitive nature of the print jobs; and

WHEREAS, the City's current copier supplier, MT Business Technologies, is able to provide a unit that will satisfy the needs of the department and the unit can be added concurrently to the existing lease agreement; and

WHEREAS, the annual cost for the new copier is \$1,188 plus a \$0.0049 black and white click charge and a \$0.0490 color click charge.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF GAHANNA, COUNTY OF FRANKLIN, STATE OF OHIO:

Section 1. That the Mayor is hereby authorized to sign the Dealer Value Lease Supplement with MT Business Technologies, Inc., for a multi-function copier machine for the Police Department Dispatch center; said Dealer Value Lease Supplement attached hereto as EXHIBIT A, and made a part herein.

Section 2. That funding is available and has been set aside in the 2016 Budget Appropriations to cover the herein costs.
