# <u>ACTION ITEM #1 – Fleet Program Auction Proceeds Supplemental</u>

<u>Appropriation:</u> When we created our current fleet program, we tried to design it to encourage efficient behaviors and discourage waste. One specific issue that had plagued us was what we refer to as "fleet creep." One negative to fleet creep is when departments acquire equipment that requires regular preventive maintenance even though it is not often used and should actually be rented when needed.

In an effort to encourage each department to "right-size" their fleet, the fleet program includes the caveat that the proceeds from the sale of equipment would be held for future equipment purchases by the department that sold the equipment. For this piece of the program to work, Council action is required to supplementally appropriate the money from the sale of equipment to the proper expense line items so that the funds can be encumbered and spent on future equipment. We have begun performing this action on a quarterly basis. We are currently bringing forward the auction proceeds from 4<sup>th</sup> quarter 2015.

We are respectfully requesting supplemental appropriations as noted in the table below and the RCA is attached:

# ACTION ITEM #2 - Insurance Claims Proceeds Supplemental

<u>Appropriation</u>: When damage occurs to City property (vehicle, streetlight, fire hydrant, etc) the repairs are paid out of our current appropriations. Our appropriations are tight and do not necessarily have enough money to cover damage from unforeseen accidents. When we receive the insurance payments, we ultimately want those funds to end up in the expense accounts that paid for the repairs. We have begun performing this action on a quarterly basis. We are currently bringing forward the insurance claims proceeds from 4<sup>th</sup> quarter 2015.

#### **UPDATES**

Hamilton Rd Central – The first phase of waterline tie-ins has been completed. The contractor has completed the tie-ins of the new service lines to the private residences. The main line tie-ins for side streets is expected to be completed by 2/12/16. These operations are being coordinated so as to provide minimal impacts to residents.

The week of 2/15/16 the contractor hopes to begin footers for the new box culverts proposed on Hamilton Road. The contractor expects to complete the installation of the box culverts this spring, which will fall in line with the second planned roadway closure on Hamilton Road. This closure will occur early this spring, however, the dates have not yet been determined. As these dates are realized, widespread notifications will be distributed to notify the community of the upcoming impact.

Pavement repairs have been completed and will continue throughout the construction zone to maintain an adequate pavement condition throughout the winter months.

Private Utility Companies continue the process of relocating power lines and installing new gas lines on Hamilton and Clark State Roads.

Somewhat mild winter weather has allowed the contractor to work on storm sewer installations, and waterline thus far, and they are hopeful that this work can continue to proceed throughout the winter months.

2016 Street Program ST-1039 – The annual street evaluation and rating has been completed that identifies maintenance needs for our City streets. The 2016 Street Program will consist of asphalt resurfacing, crack seal, and detroit street rebuilds. Below is the list of streets recommended for the program. Also attached is a map that shows the proposed maintenance areas. The map is color coded so as to identify the type of maintenance for each location.
