French, the Grantees, the receipt of which is hereby acknowledged, hereby grants unto the said Grantees, their heirs, successors and assigns, a certain nonexclusive easement for the purposes of ingress and egress and incidental purposes, upon the real estate described on the attached Exhibit "A".

This nonexclusive easement is for the benefit of Grantees' real property as shown on the attached Exhibit "B", being a 1.862 acre tract located at 6607 Clark State Road, Gahanna, Ohio. #### EXHIBIT "A"

### SANITARY SEWER EASEMENT

Situated in the State of Ohio, County of Franklin, Jefferson Township, located in part of Quarter Township 2, Township 1, Range 16, United States Military District, being a strip of land twenty (20) feet in width across part of that 2.138 acre tract of land described in the deeds to Eva J. Muller, recorded in Instrument Nos. 200006200121308 and 200406210141806 (record references recited herein are to those of the Recorder's Office, Franklin County, Ohio), said twenty (20) foot strip to lie ten (10) feet each side of the following described centerline:

Beginning at a point in the westerly line of said 2.138 acre tract of land, being the easterly line of Parcel No. 3 of those lands described in the deed to the City of Gahanna, recorded in Instrument No. 199909300246391, said point being located South 3°58'50" East, 10.00 feet from the southeasterly corner of that 1.141 acre tract of land described in the deed to Jonathan & Francis Railton, recorded in Instrument No. 200902260026587;

thence easterly across said 2.138 acre tract, being a line parallel with the southerly line of said 1.141 acre tract, South 86°50'14" East, 60.01 feet to the point of terminus of said strip in the westerly line of that 1.862 acre tract of land described in the deed to Phillip T. Helbig & Jeffrey A. French, recorded in Instrument No. 201510220149736, being an easterly line of said 2.138 acre tract, as described in December of 2015, by Carl E. Turner Jr., Registered Professional Surveyor No. 6702.

Subject, however, to all rights-of-way, if any, of previous record.

Bearings are referenced to the GRID BEARING for the centerline of Clark State Road between FCGS Monuments 1823 & 1826 (i.e. S 86°50'14"E) as determined by GNSS observations.



#### Exhibit A

Situated in the State of Ohio, in the County of Franklin and in the Township of Jefferson:

Being in Section 2, Range 16, U.M. Lands and bounded and described as follows: Beginning at a railroad spike in the center line of the Clark State Road at the North West corner of the 10 acre tract, now or formerly owned by Hattle A. Clotts (North East corner of the Machin tract):

Thence along the West line of the Clotts 10 acre tract, South 1° 12' East, passing an iron pipe at 30 feet, 686 feet to an iron pipe at the Northeast corner of the Dorothy M. Lakin tract;

Thence along the North line of said tract, South 88° 24' West, 251.41 feet to an iron pipe;

Thence North 1° 12' West, passing an Iron pipe at 656.1 feet, 684.2 feet to a point in the center line of Clark State Road;

Thence along the center line of said road, North 87° 59' East, 254.43 feet to the place of beginning, containing four acres, more or less.

Being located in Section 2, Township 1, Range 16, United States Military Lands, and bounded and described as follows:

Beginning at a point in the centerline of Clark State Road, which point is located South 87° 59' West, 194.37 feet from a railroad spike at the intersection of the said centerline with the Easterly line of the said Section 2, said railroad spike being also the Northeasterly comer of the original tract conveyed to Ernest R. and Lucille A. Sager by deed of record in Deed Book 1246, Page 79 Recorder's Office, Franklin County, Ohio;

Thence South 1\* 13' East (being parallel to and 60 feet Easterly at right angles from the Westerly line of the said Sager tract and passing an Iron pin at 30.0 feet), 416.20 feet to an iron pin:

Thence North 87° 59' East, (being parallel to the centerline of the said Clark State Road), 194.41 feet to an iron pin in the Easterly line of the said Sager Tract and the Easterly line of the said Section 2;

Thence along the said line, South 1° 13' 30" East, 266.80 feet to an iron pin in the root of a Pin Oak Tree and at the Southeasterly corner of the said Sager Tract;

Thence along the Southerly line of the said tract and the Northerly line of the 16 acre tract conveyed to George A. and Betty L. Hannah by deed of record in Deed Book 2361, page 249, Recorder's Office, Franklin County, Ohio, South 86° 23' 30" West, 254.41 feet to an iron pin found at the Southwesterly corner of the said Sager tract;

Thence along the Westerly line of the sald tract and the Easterly line of the 4.0 acre tract conveyed to George A. and Betty L. Hannah by deed of record in Deed Book 2605, page 653, Recorder's Office, Franklin County, Ohio, North 1° 13' West (passing an iron pin at 655.09 feet), 683.19 feet to the Northwesterly corner of the said Sager tract in the centerline of the said Clark State Road;

Thence along the said centerline, North 87° 59' East, 60.0 feet to the place of beginning, containing 2.138 acres, more or less.
